

ORDINANCE NO. 142

An Ordinance Annexing Lots 19, 20 and 21 in  
Block 149 of Wildwood, to the Village of Mahtomedi.

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI DO ORDAIN  
AS FOLLOWS:

Section 1. That pursuant to that certain petition signed by all of the owners of Lots Nineteen (19), Twenty (20) and Twenty-one (21) in Block One Hundred Forty-nine (149) of Wildwood, in Washington County, Minnesota, containing less than two hundred acres, abutting on a Westerly side of the Village of Mahtomedi, requesting the annexation of said land to said Village, said Petition having been duly filed with the Clerk of said Village; and it appearing that such annexation will be to the best interests of the Village and of the territory affected, the Village boundaries of the Village of Mahtomedi are hereby extended to include said land described by the following boundary lines:

Commencing at the Southwesterly corner of Lot Nineteen (19) in Block One Hundred Forty-nine (149) of Wildwood; thence Northeasterly along the Northwesterly line of said Lot to the Northwesterly corner thereof; thence Southeasterly along the Northeasterly lines of Lots Nineteen (19) and Twenty (20) and the extended line of the Northeasterly line of said Lot Twenty (20) to the West line of the East Half of the Northeast Quarter ( $E\frac{1}{2}$  of  $NE\frac{1}{4}$ ) of Section Twenty (20), Township Thirty (30) North, Range Twenty-one (21) West; (being a Westerly boundary line of the Village of Mahtomedi) thence South along said West boundary line to the intersection thereof with the center line of Marshall Street in the plat of Wildwood; thence Northwesterly along said center line of Marshall Street to a point intersected by the extended Northwesterly line of said Lot Nineteen (19); thence Northeasterly along said extended line to the point of beginning.

and that said territory is hereby made a part of the Village of Mahtomedi as effectually as if the same had originally been a part of said Village.

Section 2. This Ordinance shall take effect and be in force upon the filing of a certified copy thereof with the County Auditor of Washington County and the Secretary of State of the State of Minnesota and with the Minnesota Municipal Commission and from and after its publication.
