ORDINANCE NO. 60-7

AN ORDINANCE ANNEXING PROPERTY TO THE VILLAGE OF PRIOR LAKE, MINNESOTA

WHEREAS, Nick Zweber and Lucille E. Zweber, hugband and wife, being the owners of the following described property, to-wit:

That certain tract of land lying in the N1/2 of Section 2 Township 114 Range 22, described as follows:
