ORDINANCE NO. 60-7

AN ORDINANCE ANNEXING PROPERTY TO THE
VILLAGE OF PRIOR LAKE, MINNESOTA

WHEREAS, Nick Zweber and Lucille E. Zweber, husband and wife, being the owners of the following described property, to-wit:

That certain tract of land lying in the NE 1/2 of Section 2 Township 114 Range 22, described as follows:

Beginning at the NE corner of the Southeast quarter (SE 1/4) of the Northwest quarter (NW 1/4) of Section 2 Township 114 Range 22, thence North 41.5 feet; thence West 216 feet; thence South 150 feet; thence East 183 feet; thence North 5 feet; thence East 33 feet; thence North 103.5 feet to the place of beginning,

have petitioned the Village Council of the Village of Prior Lake, Minnesota to have the above described land which lies outside the Village of Prior Lake, Minnesota, annexed to the Village of Prior Lake, Minnesota; and

WHEREAS, the Village Council deems it advisable and in the public interest that said property be so annexed; and

WHEREAS, the Village Council does hereby find and determine that annexation will be to the best interest of the Village, that the above described property abuts upon the Village of Prior Lake, is not included in any other municipality, is unplatted, does not exceed 200 acres, and is so conditioned as properly to be subjected to municipal government,

NOW THEREFORE, the Village Council of the Village of Prior Lake, Minnesota, does ordain as follows:

SECTION 1.

That the following described property, to-wit:

That certain tract of land lying in the NE 1/2 of Section 2 Township 114 Range 22, described as follows:

Beginning at the NE corner of the Southeast quarter (SE 1/4) of the Northwest quarter (NW 1/4) of Section 2 Township 114 Range 22, thence North 41.5 feet; thence West 216 feet; thence South 150 feet; thence East 183 feet; thence North 5 feet; thence East 33 feet; thence North 103.5 feet to the place of beginning,

which lies outside the corporate limits of the Village of Prior Lake, Minnesota, be and the same is hereby annexed to the Village of Prior Lake, Minnesota, and said property is hereby declared to be an addition to said Village.

Upon the execution date of this Ordinance, such property shall become a part of said Village as effectively as if it had been originally a part thereof.

SECTION 2.

This Ordinance shall take effect and be in force from and after its passage and publication and after filing as hereinafter set forth. The Village Clerk is hereby directed to cause certified copies of this Ordinance to be recorded and filed in the Office of the Register of Deeds of Scott County, Minnesota, the Office of the County Auditor, Scott County, Minnesota, the Office of the Secretary of the Municipal Commission, State of Minnesota, and in the Office of the Secretary of the State of Minnesota.
