

ORDINANCE NO. 24

An Ordinance extending the corporate limits of the Village of Dellwood, Washington County, Minnesota to include certain platted land.

Section 1. A petition has been filed with the governing body of the Village of Dellwood, Minnesota by all of the owners in number of the following described real estate to have such land included within the Village of Dellwood, Minnesota:

All of the land included in the plat of Pine Tree Hills as now on file and of record in the office of the Register of Deeds of Washington County, Minnesota.

Section 2. A quantity of land embraced within the foregoing description and bounded as described is / <sup>136.8</sup> acres.

Section 3. The Village Council hereby determines and ordains (1) that the annexation will be to the best interests of the Village of Dellwood, Minnesota and of the territory affected; (2) that the territory described herein abuts upon the Village and is so conditioned as properly to be subjected to Village government.

Section 4. The Village Council does ordain that the corporate limits of the Village are hereby extended to include the property described in Section 1, and the same is hereby annexed to and included in the Village of Dellwood as effectually as if it had originally been a part thereof.

Section 5. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State.

Section 6. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 5.




