Section 2. A quantity of land embraced within the foregoing description and bounded as described is 24.24 ecres.

Section 3. The Village Council hereby determines and ordains (1) that the annexation will be to the best interests of the Village of Dellwood, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the Village and is so conditioned as properly to be subjected to Village government.

Section 4. The Village Council does ordain that the corporate limits of the Village are hereby extended to include the property described in Section 1, and the same is hereby annexed to and included in the Village of Dellwood as effectually as it it had originally been a part thereof.

Section 5. The Village Clerk 13 hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State.

Section 6. This Ordinance takes effect and upon its passage and publication and the filing of the certified copies as directed in Section 5.
