1. Section 9 of Shapter 3 of the Charter of the City of Springfield, which now reads no follows:

Section 9 -- QUALITUME (HIGHER FOLICE EFFACINETY): No person shall be eligible to appointment in the Folice Jopartment who is not a citizen, or shall any person be eligible to appointment therein, other than as a special policemen, who has not been a resident of the City of Springfield for at least one year prior to his appointment.

is amended to read as 2011000:

Section 9 -- QUALTITATIONS OF POLICENTH: No person shall be eligible to appointment in the Police Department who is not a citizen of the United States. The Thief of Police must become a resident of the City of Springfield within 60 days after his appointment to that office.

2. Section 3 of Chapter 1 of the Charter of the City of Springfield, which now reads as follows:

Section 3 — UNIDE: The City of Springfield, Brown Jounty, Minnesota, shall be divided into two wards and the center line of Marshall Avenue in said City extended to the north and south limits of said City, shall be the dividing line between said two wards. That portion the City lying to the Mast of said center line of Marshall Avenue shall be known as Mard Mumber The (1), and that portion of the City lying to the west of said center line of Marshall avenue shall be known as Ward Number Two (2) of the City of Springfield.

is emended to read as follows:

Section 3 - MARDS: The City of Springfield, Brown County, Minnesota, shall be divided into two wards, and the center line of Spring Avenue in said City extended to the north and south limits of said City, shall be the dividing line between said two wards. That portion of the City lying to the East of said center line of Spring Avenue shall be known as Ward Cne, and that portion of the City lying to the West of said center line of Spring Avenue shall be known as Ward Two.

3. Section 7 of Chapter 15 of the Charter of the City of Springfield, which now reads as follows:

Section 7 — POWERS AND DUTTES OF THE CON ISSION: Except as otherwise provided in this chapter the Commission shall have the full and exclusive control of and power over the entire waterworks system, storm and Sanitary Sewers, including Sewage Disposal Plant, the Electric Light Plant and Distribution System, the Filteration Plant, and the Steam Heating System now owned by the City and of any other utility now or at any time hereafter camed or operated by the City and determined by the City Council, including all buildings, structures, waterinery, appearated, equipment, materials, and supplies and all other property belonging to or appurtenent to the same, and shall also have full and exclusive control and power over all moneys, bonds, certificates of indebtedness, warrants, and other securities in the current or any other fund of the Commission as now established or such as may be issued and created in the future.

is amended to read as follows:

Section 7 -- POWERD AND JUTIES OF THE COMMISSION: Except as otherwise provided in this chapter, and provided that all storm

secors shall be under the full and exclusive central, owner-chip, and jurisdiction of the City Council, and it alone shall construct, repair, ir grove the same, provide for the method of financing and payment therefor, establish and enforce rules and regulations pertaining thereto, prescribe penalties for the violation thereof, and the City Council shall have such other authority as shall be reasonable, necessary, or incidental to the foregoing enumerated powers. The Commission shell have the full and exclusive control of end power ever the entire voterworks system, the Sanitary Sewers, including Sewage Asposal Plant, the Electric Light Plant and Distri-bution System, the Filtration Plant, and the Steam Heating System now owned by the City and of any other utility now or at any time hereafter owned or operated by the Sity and determined by the Sity Souncil, including all buildings, structures, machinery, apparatus, equipment, materials, end supplies, and all other property belonging to or appurtenent to the same, and shall also have full and exclusive control and power over all moneys, bonds, certificates of indebtedness, warrants, and other securities in the current or any other fund of the Commission as now established or such as may be issued and orcated in the future.
