1 We, the undersigned inspectors, duly appointed by the County Board  
2 of Morrison County, Minnesota to act as judges of election at an  
3 election held on the 4th day of January, 1916 for the purpose of  
4 voting on the incorporation of the village of Sobieski, in the  
5 said Morrison County, a more particular description of the land  
6 embraced within said proposed village is set out in the petition  
7 duly filed in the office of the county auditor of the said Morri-  
8 son County, to which petition and all the orders and proceedings  
9 herein reference is made, do hereby certify as follows:

10 1) That the said election was held <sup>on January 4th, 1916</sup> in the hall known as the Mrozek  
11 hall, on the second floor of the building known as the Mrozek  
12 building, now owned by Stanislaus Perowitz, and located in the  
13 Town of Swan River, said County of Morrison. That the polls were  
14 open from the hour of 9 in the ~~fore~~ noon of the said day until  
15 the hour of 5 in the ~~after~~ noon of the said day. That

16 2) That they have canvassed the ballots cast as the said election  
17 and find that there were in all forty-eight ballots cast; that  
18 there were cast "For incorporation - yes" forty ballots, and  
19 that there were cast "For incorporation-no-" eight ballots; so  
20 that there were 40 ballots cast in favor of incorporation of the  
21 said village and 8 against the incorporation of the said village.
