ORDINANCE NO. 242

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF HUTCHINSON TO INCLUDE CERTAIN PLATTED LAND IN THE AUDITOR'S PLAT OF THE PART OF THE NORTHWEST QUARTER OF SECTION 1, TOWNSHIP 116, RANGE 30, LYING SOUTH OF THE MILL POND.

Section 1. A petition has been filed with the governing body of the City of Hutchinson, Minnesota by the sole owner or all of the owners in number of the following described real estate to have such land included within the City of Hutchinson, Minnesota:

Beginning at a point 803.88 feet West of the Southeast corner of the Northwest Quarter of Section 1, Township 116, Range 30 West; thence running North 487.74 feet; thence West 535.92 feet; thence South 487.74 feet, and thence East along the South line of said Northwest Quarter of Section 1, Township 116, Range 30, 535.92 feet to the place of beginning, excepting the southerly 2 rods of said tract; said tract being also known as Lot 21 of Auditor's Plat of the Northwest Quarter of Section 1, Township 116 North, Range 30 West.

Section 2. The quantity of land embraced within the foregoing description, and bounded as described, is less than 200 acres.

Section 3. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Hutchinson, Minnesota and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City Government.

<u>Section 4.</u> Therefore, the City of Hutchinson, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the City of Hutchinson, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
