ORDINANCE # 175

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF STAPLES
AND INCORPORATING ADDITIONAL TERRITORY THEREIN.

The City Council of the City of Staples do ordain as follows:

Section 1. Pursuant to a petition duly signed by the owners of the following described property, and which property is suitable for municipal government and which property abuts and is adjacent to the City of Staples, Todd County, Minnesota, and which property is described as follows, to-wit:

That part of the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ -SE $\frac{1}{4}$) of Section 1, Township 133 North Range 33 West, described as follows:
Commencing at the point on the west line of said SE $\frac{1}{4}$ -SE $\frac{1}{4}$ which is 441.9 feet north of the southeast corner of said SE $\frac{1}{4}$ -SE $\frac{1}{4}$, said point being 75 feet north of the intersection of said west line with the centerline of State Highway Number 10, thence south 88 degrees 00 minutes east 33 feet along the right-of-way line of State Highway Number 10 to the place of beginning, thence south 88 degrees 00 minutes east 215 feet continuing along said highway right-of-way line; thence north 624 feet; thence north 88 degrees 00 minutes west 215 feet; thence south 624 feet to the place of beginning.
(containing 3.08 acres)

The corporate limits of the City of Staples shall be changed so as to include the above described lands within its said limits; and the above described lands shall hereafter be included within the corporate limits of said City of Staples and shall be a part of said City of Staples and shall be governed as other lands and territory in said City of Staples are now governed.

Section 2. The aforesaid lands and territory shall be annexed to the City of Staples, and this ordinance shall take effect and be in full force and effect from and after its passage, approval, and publication.

Section 3. The City Clerk of the City of Staples is hereby directed to forward a certified copy of this ordinance to the County Auditor of Todd County, Minn. and to the Secretary of the State of Minnesota, and to the Commission on Municipal Consolidation & Annexation.

The above ordinance was passed at a regular meeting of the City Council of the City of Staples on this 24th day of May 1960.
