OMDINANCE NO. 93

VILLAGE OF FOLEY, BEHTON COUNTY, HISPNESOFA

AN ONDIMINOS ANDEXIIG LAND TO THE VILLAGE

That Whereas the following described real estate in Park Lots Addition to Foley, which Addition is in the West Half of the Southwest Quarter (Wa of Sun) of Section Twenty-five (25), Township Thirty-seven (37), Renge Twentynine (29), is of record in the name of Mike Zulawski, to-wit:

The North 34.9 feet of Lot Thirteen (13), and all of Lot Fourteen (14) in Park Lots Addition to Foley.

and the following described land is of record in the name of Raymond P. Tadych, to-wits

Lot Seventeen (17) in Park Lots Addition to Foley.

and said lands are completely surrounded by land within the limits of the Village of Foley; and

WHEREAS, the Village Council of the Village of Feley, at its regular meeting held on the first day of August, 1961, adopted a resolution that it was the intention of said Villago Council to annex the above described property to the Village of Foley, and set the date for the hearing on said pesolution for the regular Council meeting to be held on the fifth day of September, 1961, at 7:30 o'clock P. M., and that a copy of said resolution was personally served upon the owners of said real estate and upon their respective wives on the 12th day of August, 1961, and proof of such service duly filed with the Village Clork, and:

MEREAS, the said Mike Zulavski and the said Naymond P. Todych appeared at said hearing held on the fifth day of September, 1961, at 7:30 o'clock P. M. and consented to the annexation of their land above described to the Village; and

WHEREAS, the Village Council at said hearing unanimously determined that the annexation of said land will be to the best interests of the Village and of the territory affected.

NOW, THEREFORE, THE VILLAGE COURCIL OF THE VILLAGE OF FOLEY, MINNESOTA, DO ORDAIN AS FOLLOWS:

Section 1. That the real estate above described, which is of record in the name of Mike Zulawski and in the name of Raymond P. Tadych, be annexed to the Village limits of the Village of Foley.

Section 2. That the land above described is platted and is less than 200 scres in area and that the annexation of said land to the village limits shall be desmed complete upon the publication of said ordinance and the filing of a certified copy thereof with the County Auditor, the Secretary of State and the Minnesota Funbipal Commission, and that a copy of this ordinance be recorded in the office of the Register of Deeds of Benton County, Minnesota.
