












## ORDINANCE NO. 415 (Special)

An Ordinance Extending the Corporate Limits of the City of Willmar to Include Certain Land Platted as a Portion of a Subdivision, to be used as a City Street, (which land described in this Ordinance is to be known as Minnesota Avenue East when extended).

BE IT ORDAINED BY THE CITY OF WILLMAR AS FOLLOWS:

SECTION 1: Whereas a Motion has been made, seconded and unanimously carried by the City Council of the City of Willmar, Minnesota, as owner of the following described real property, whereby the City petitioned to have such land included within the City of Willmar, Minnesota, as follows:

Part of the South Half of the Northeast Quarter  $(S\frac{1}{2} NE\frac{1}{4})$  Section Fourteen (14), Township One Hundred Nineteen (119), Range Thirty-five (35), described as follows: Commencing at a point 715 feet South and 393.61 feet East of the Northwest corner of the Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$  NE $\frac{1}{4}$ ) Section Fourteen (14), Township One Hundred Nineteen (119), Range Thirty-five (35); thence running East and parallel with the North line of said South Half of Northeast Quarter (S $\frac{1}{2}$  NE $\frac{1}{4}$ ) Section Fourteen (14), to the Southwest corner of Lot Seven (7), Block Seven (7), Erickson's Third Addition to the City of Willmar; thence South on the East line of Thirteenth Street East extended a distance of 70 feet to a point; thence West and parallel with the North line of said South Half of the Northeast Quarter (S $\frac{1}{2}$  NE $\frac{1}{4}$ ) to the East line of Welch's Addition to the City of Willmar, thence North along said line a distance of 70 feet to the point of beginning.

SECTION 2: The quantity of land embraced within the foregoing description, and bounded as described is 2.1 acres.

SECTION 3: The City Council hereby makes the following determination, to-wit:

1) That the annexation will be to the best interest of the

City of Willmar, Minnesota, and the territory affected.2) That the territory described herein abuts upon the City and is so conditioned as properly to be subject


to City Government.

SECTION 4: Therefore, the City of Willmar, Minnesota, hereby ordains and declares that the property hereinbefore described be, and the same hereby is, annexed to and included in the City of Willmar, Minnesota, as effectually as if it had originally been a part thereof.

SECTION 5: This Ordinance shall be final and shall take effect and be in full force from and after filing a certified copy thereof with the Minnesota Municipal Commission, the County Auditor of Kandiyohi County, and the Secretary of State of the State of Minnesota, and from and after its passage and publication.
