

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF NORTHINGTON TO INCLUDE CERTAIN UNINCORPORATED LAND.

The City Council of the City of Northington do ordain:

Section 1. A petition has been filed with the City Council of the City of Northington, Minnesota, signed by all of the owners in number, of the following described real estate to have such land included within the City of Northington, Minnesota:

That part of the West half (1/2) of Section 20, Township 102 North, Range 40 West, DeLore County, Minnesota, described as commencing at the southeast corner of Street Lot "A" in Auditor's Plat of Blocks 9 and 11 of Ludlow Acres; thence North on the East line of said Street Lot "A", 125 feet; thence East and parallel with the South line of said Street Lot "A" extended, a distance of 30 feet; thence South and parallel with the East line of said Street Lot "A", a distance of 125 feet; thence West a distance of 30 feet to the point of beginning.

Section 2. The quantity of land embraced within the foregoing description, and bounded as described, is eight one-hundredths (.08) acres.

Section 3. A hearing was duly held by the City Council of the City of Northington, Minnesota, on the proposed annexation after publication of the notice of hearing as required by City Charter.

Section 4. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Northington, Minnesota, and of the territory affected; (2) that the territory described herein does upon the City and is so considered as properly to be subjected to city government.

Section 5. The corporate limits of the city are hereby extended to include the property described in Section 1, and the same is annexed to, and included in the City as effectually as if it had originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Corporation, the County Auditor, and the Secretary of State.

Section 7. This ordinance shall take effect upon its passage and publication and upon filing of the certified copies as directed in Section 6.


