VILLAGE OF FOLIX, BENTON COURT, MINNESOTA

AT ORDINARCH EXTREMING THE VILLAGE BORNLAWINS

said Village and their spouses have filed with the Village Clerk their potition asking that said lands be annexed to the Village; and

THE EAS, the Village Council of the Village of Foley has determined that the annexation of said lands is in the best interest of the Village of Foley and of the territory affected thereby.

NOW, THEREFOLD, THE VILLAGE COUNCIL OF THE VILLAGE OF FOLEY, MINISOUTA, DE CREATE AS FOLLOWS:

Section 1. That the Village boundaries of the Village of Foley are hereby extended so as to include the following described parcels of land abutting upon said village:

A. Commencing at a point 33 feet West of the East Cuarter corner of Section Twenty-six (26), Township Thirty-seven (37), Range Twenty-nine (29). said point being the point of beginning: thence Westerly along the quarter line a distance of 206 feet; thence deflecting to the left at 90 degrees for a distance of 193.35 feet, said point being on the North Right-of-Way line of Trunk Highway No. 23; thence northeasterly along Trunk Highway Right-of-Way a distance of 126 feet; thence continuing along sight triangle of said Right-of-Way for a distance of 138.7 feet to intersect West line of Eighth avenue in the Village of Foley; thence Northerly along West line of Eighth Avenue for a distance of 33 feet to the point of beginning, being in Northeast Cuarter of the Southeast Cuarter of said Section Twenty-six (26), and containing 0.60 acres, more/less; which is of record in the name of Charlotte T. Holdridge, a widow, and occupied by Albert H. Petersen and Dorthy E. Petersen, husband and wife, under a Contract for Deed from said Charlotte T. Holdridge.

B. That part of the Northwest Quarter (Not) of Section Twenty-five (25), Township Thirty-seven (37), Range Twenty-nine (29), described as follows: Commoncing two (2) rods north of the Southwest corner of the Northwest Quarter (NW &), Section and Range Aforesaid; thence running east a distance of 16 rods; thence morth at right angles 50 rods; thence west 16 rods to west line of said section; thence south 50 rods to the place of beginning, excepting therefrom a tract described as follows: Commencing at a point 2 rods north of the Southwest corner of said NW; thence east 16 rods to a point which is the point of peginning; therce north 125 feet; thence west 130 feet; thence south 125 feet; thence east 130 feet to the point of beginning; which is of record in the name of Albert Visenor and Alma Visenor, husband and wife.
