



ORDINANCE NO. 417
(Special)

(F-3)

An Ordinance Extending the Corporate Limits of the City of Willmar to include Certain Lands not Exceeding Two Hundred Acres, and Located in Various Parts and Portions of what is now Platted and Known as "Sunnyside Addition" and "Leary's Addition", together with Certain Properties Located in the Same General Area to be used for Religious and Church Purposes and owned by the Redeemer Lutheran Church, which last named Property will not be Platted, except that the Same Shall Hereafter be Known as the "Redeemer Church Addition to the City of Willmar" for general descriptive purposes.

BE IT ORDAINED BY THE CITY OF WILLMAR AS FOLLOWS:

SECTION I.

Petitions have been filed with the governing body of the City of Willmar, Minnesota, by the sole owner or owners of the following described real estate, to have such land included within the City of Willmar, Minnesota, as follows:

1. (That area encompassed within what is known as "Sunnyside Addition"). Lots One and Two (1 and 2) and the North Ten (N 10) feet of Lot Three (3) in Block Two (2), Sunnyside Addition. (Presently owned by Municipal Utilities Commission—City of Willmar); Lots One, Two, Three and Four (1, 2, 3 and 4) of Block One (1) in Sunnyside Addition, (Arthur Palmer property); Lots Seven, Eight, Nine and Ten (7, 8, 9 and 10) of Block One (1) of Sunnyside Addition, (Clifford Peterson property); Lots Eleven and Twelve (11 and 12) of Block One (1), of Sunnyside Addition, (Helmer A. Iverson property); Lots Thirteen and Fourteen (13 and 14) of Block One (1), in Sunnyside Addition (Roy Paulson property).

2. (That area encompassed within what is known as "Leary's Addition"). Lots Eleven, Twelve and Thirteen (11, 12 and 13) all in Block Two (2) in Leary's Addition to Willmar; Lots Two, Three, Four, Five, Eight, Nine (2, 3, 4, 5, 8, 9) and the South Half (S ½) of Lot Ten (10) of Block one of Leary's Addition to the City of Willmar.

3. (That area encompassed within what is known as "Redeemer Lutheran Church Property"). All that part of the Northeast Quarter of the Northeast Quarter (NE¼ of NE¼) of Section Twenty Two (22), Township One Hundred Nineteen (119), Range Thirty Five (35), County of Kandiyohi, Minnesota, described by metes and bounds as follows, to-wit: Commencing at the Southwest corner of said Northeast Quarter of the Northeast Quarter (NE¼ of NE¼) of said Section Twenty Two (22), thence North along the West line thereof to a point which is Two (2) rods North of the Northwest corner of the South Half (S½) of the Northeast Quarter of the Northeast Quarter (NE¼ of NE¼) of said Section Twenty Two (22); thence East and parallel with the North line of said South Half (S ½) of the Northeast Quarter of the Northeast Quarter (NE¼ of NE¼) of said Section a distance of Five Hundred Thirty Four (534) feet to a point on the West line of the Washington School Property; thence South on and along the Westerly line of said Washington School Property a distance of Seventy Five (75) feet; thence West and parallel with the North line of the South Half (S ½) of said Northeast Quarter of the Northeast Quarter (NE¼ of NE¼) of said Section Twenty Two (22), a distance of Two Hundred Forty Nine and eight tenths (249.8) feet to a point on the center line of Fifth Street West extended Southerly; thence South on and along said centerline of Fifth Street extended Southerly to a point on the South line of said Northeast Quarter of the Northeast Quarter (NE¼ of NE¼) of said Section Twenty Two (22); thence Westerly on and along said South line of the Northeast Quarter of the Northeast Quarter (NE¼ of NE¼) of Section Twenty Two (22), a distance of

Two Hundred Eighty Four and two tenths (284.2) feet to the place of beginning; containing five (5) acres more or less.

SECTION 2

The quantity of land embraced within the foregoing description, and all of them, and bounded as described is approximately 9 acres.

SECTION 3

The City Council hereby makes the following determination, to-wit:

1. That the annexation will be to the best interest of the City of Willmar, Minnesota, and of the territory affected.
2. That the territory described herein abuts upon the City and is so conditioned as properly to be subject to City Government.

SECTION 4

Wherefore the City of Willmar, Minnesota, a Municipal Corporation of said State of Minnesota, hereby ordains and declares that the property hereinbefore described be, and the same is hereby, annexed to, and included in the City of Willmar, Minnesota, as effectually as if it had originally been a part hereof.

SECTION 5

That the said property described in the first description, numbered one, be known as "Sunnyside Addition"; that the said property described in the description numbered two, be known as Leary's Addition"; that the property described in the description numbered three, be known, for convenience, as the "Redeemer Lutheran Church Property", it not being intended that said property be platted otherwise but that it so be known when and if the same shall be platted, as shall the others.

SECTION 6

This Ordinance shall be final and shall take effect and be in full force from and after filing a certified copy hereof with the Minnesota Municipal Commission, the County Auditor of the Kandiyohi County, Minnesota, and the Secretary of State of the State of Minnesota, and from and after its passage and publication.
