

AN ORDINANCE AMENDING CERTAIN PROVISIONS TO ALL FUTURE AND UNPUBLISHED ORDINANCES OF THE CITY OF FAIRMONT, MINNESOTA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FAIRMONT, MINNESOTA, AS FOLLOWS:

Section 1. -- That a petition presented to the City Council of the City of Fairmont, Minnesota, requesting that property hereinafter described be annexed to the City of Fairmont, has been signed by a majority of the owners of said property; that the said property adjoins upon the corporate limits of the City of Fairmont, Minnesota; that it is so conditioned to be properly subject to municipal government; that the unincorporated part thereof does not exceed two hundred (200) acres in area; that the annexation will be to the best interests of the municipality and the territory affected; that said petition is in accordance with U.S.A. Section 414.03 and is in all things sufficient.

Section 2. -- That a hearing on said petition is required by U.S.A. Section 414.03 has been held pursuant to proper notice thereof, proof of which notice is on file with the City Clerk of the City of Fairmont, Minnesota.

Section 3. -- That the property set forth in said petition is located in the County of Martin, State of Minnesota, and described as follows, to-wit:

Lots Eighteen (18) to Forty-Four (44) both inclusive and Quarter Number Two (2) in Block One (1) and Lots Nine (9) to Twenty-six (26), both inclusive, in Block Two (2), all Sherburne, according to the map or plat thereof on file and of records in the office of the Register of Deeds in and for said County and State,

and that said property be, and the same hereby is, extended to and incorporated within the corporate limits of the City of Fairmont, Minnesota, and is hereby declared to be a part of the City of Fairmont, Minnesota, as effectually as if the same had been originally a part thereof and that the corporate limits be and the same hereby are extended to include said property.


Section 4. -- That this ordinance shall be in force and effect from and after its passage and publication and the filing of a certified copy with the Municipal Commission, the County Auditor, and the Secretary of State, as required by law. In addition, the City Clerk is hereby directed to file a certified copy of this ordinance in the office of the Register of Deeds for Martin County, Minnesota.
