ORDINANCE NO. 120

AN ORDINANCE PROVIDING FOR THE ANNEXATION
OF CERTAIN TERRITORY TO THE VILLAGE OF
WALKER ON PETITION OF WALKER INDUSTRIES, INC.

WHEREAS, Walker Industries, Inc., has presented to the village council
of the Village of Walker, Minnesota, a petition as follows:

The undersigned, being the owner of all of the property
hereinafter described, said tract constituting unplatted property
which does not exceed 200 acres and which abuts upon the Village
of Walker, Minnesota, do hereby petition that said land be annexed
to the Village of Walker; that the description of said property
and the owner thereof is as follows: Description: All that
portion of the NE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 34, Township 142, Range 31,
Cass County, Minnesota, lying and being west of State Highway #34.
Owner: Walker Industries, Inc.

That this petition is made pursuant to Section 414.03,
Subdivision 7, of the Minnesota General Statutes,

which said petition is duly acknowledged by said parties; and,

WHEREAS, the said council by resolution duly passed has granted said
petition:

NOW, THEREFORE, the village council of the Village of Walker does ordain
as follows:

Section 1. That the following described land abutting upon the
Village of Walker, to-wit: All that portion of the NE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 34,
Township 142, Range 31, Cass County, Minnesota, lying and being west of State
Highway #34, be and the same is hereby annexed to, included within, and made a
part of the incorporated Village of Walker.

Section 2. This ordinance shall be in force from and after its
passage and publication and the filing of certified copies thereof in the office
of the County Auditor of Cass County, Minnesota, in the office of the Secretary
of State of the State of Minnesota, and in the office of the Municipal Commission
of the State of Minnesota.




