CHURCH, a petition has been filed with the governing body of the City of Albert Lea, Minnesota, signed by all of the owners of the following described real estate to have such land included within the City of Albert Lea. (Enclosure)

All that part of Edgerton Farms and Grove, Freeman Co., Minnesota, and of Meadow Park, a subdivision of a part of Lots 2, 4, 6, and 8; Lots 10, 12, 14, 16, 18, 20 and a part of Lot 22; Lot 41, 42, 43, 44, 45, 46, 47, 48, 49, 50, 51, 52, 53, 54 and a part of Lot 55 of Edgerton Farms and Lots 44, 45, 46, 47, 48 and a part of Lot 1 of Edgerton Grove, Freeborn County, Minnesota, also including Edgerton Drive as plotted from the SW Corner of Lot 41 Edgerton Grove northwesterly to a point 180 feet north of the SW Corner of Lot 22 Edgerton Farms, including all the lots, blocks, streets, alleys, drives and Meadow Park which lies north of the above described as follows: Beginning at a point 2380.8 feet South and 162.7 feet South 08° 45' West of the Northwest corner of Sec. 5, in Township 102 North of Range 21 West of the Fifth Principal Meridian, thence North 52° 19' East 777.9 rods; thence South 61° 28' East 251 feet; thence South 52° 19' East 250 feet; thence South 01° 53' East 200 feet; thence due East to the Westwesterly line of Town Highway No. 13; less and excepting therefrom Lots 1, 3, 5, 7, 9, 11, 13, 35, 37, 39, and 21 to 49 (including Edgerton Farms and Grove), Freeborn Co., Minnesota, and less the following described premises: Beginning at a point that is 710 feet South and 100 feet East of the Northwest corner of Section 5, Township 102 North, of Range 21 West of the Fifth Principal Meridian, the above described point being on the South line of Studio Street and is the place of beginning of the tract herein described; thence East 900 feet, thence due South 507.5 feet to the place of beginning. All of the above described premises lying and being in the West Half of the Northwest Quarter and the Northeast Quarter of the Southwest Quarter of Section 5, and the West Half of the Northwest Quarter of Section 5, all in Township 102 North, of Range 21 West of the 5th P.M., and being in the County of Freeborn and State of Minnesota.

Sec. 2. That the property hereinbefore described be and the same is hereby
named to, and included in the City of Albert Lea as effectually as if it had
originally been a part thereof.

Sec. 3. That the property covered by this ordinance is hereby taxed as
P-2, one and two finally dissolved.

Sec. 4. That this ordinance shall be final and shall take effect and be in force from and after filing certified copies thereof with the Minnesota Municipal Consolidation, the County Auditor and the Secretary of State and from and after its publication and publication.
