

CHAPTER NO. 2,98

AN ORDINANCE TO ANNEX a certain tract of land to the City of Montevideo and declaring said tract to be an addition to and a part of the City of Montevideo.

WHEREAS, a petition has been filed with the City Council of the City of Montevideo by the owner in fee of the following described tract of land lying and being in the County of Chippewa, State of Minnesota, to-wit:

South one-half ( $\frac{1}{2}$ ) of West One-half ( $\frac{1}{2}$ ) of Lot Eleven (11)  
In Block Two (2) of Ira B. Wolfe's Second Subdivision In the  
Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$ ) of Sec-  
tion Six (6) Township One Hundred Seventeen (117) Range  
Forty (40)

praying that said tracts be annexed to and made a part of the City of Montevideo, and

WHEREAS, It appears that said tract of land abuts upon the Incorporated City of Montevideo, that said petitioner is the sole owner in fee thereof, that said tract of land is suitable for residential purposes and is so located as to be properly subject to annexation to the City of Montevideo and is suitable and adoptable to municipal purposes and municipal regulations, control government. That it is to the best interests of both the Petitioner and the City that said tract of land be annexed to the City of Montevideo and of the territory affected.

AND, THEREFORE, the City of Montevideo does ordain as follows:

Section I. That the certain tract of land lying and being in the County of Chippewa, State of Minnesota, described as follows, to-wit:

South One-half ( $\frac{1}{2}$ ) of West One-half ( $\frac{1}{2}$ ) of Lot Eleven (11) In Block Two (2) of Ira B. Wolfe's Second Subdivision In the Southeast Quarter of the Southeast Quarter ( $\text{SE}^{\frac{1}{4}}\text{SE}^{\frac{1}{4}}$ ) of Section Six (6) Township One Hundred Seventeen (117) Range Forty (40).

be and the same is hereby declared to be annexed to the City of Montevideo and that said tract of land is hereby declared to be an addition to the City of Montevideo and is hereby made a part of said City of Montevideo and of the residence district thereof as defined and described by the ordinances of said City.
