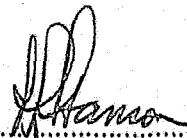
1. That he is the duly appointed, qualified, and acting Recorder of the City of Austin.

Extending the corporate limits of the City of Austin to the North.

WHEREAS all of the cures owning the premises hereinafter described have petitioned the Common Council of Austin, Minnesota, to have the hereinafter described premises annexed to the corporate limits of Austin, Minnesota, and

WHEREAS said premises adjoin the City of Austin and are subject to incorporation within the corporate limits of Austin, Minnesota, by petition to the governing body of the City of Austin, and

WHEREAS it is in the best interest of the City of Austin and also the premises hereinafter described that said premises be annexed to the City of Austin and said premises are well fitted to be under municipal government and are well adapted for municipal use, and

WHEREAS the premises hereinafter described desired to be annexed are less than 120 acres and the petition for annexation has been signed by all of the owners of the annexed property.

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTION 1.

That the land hereinafter described be added to and incorporated within the corporate limits of the City of Austin, Minnesota, and said Common Council does hereby declare said premises hereinafter described to be incorporated within and to be a part of the City of Austin, Minnesota. The premises are described as follows:

Beginning at a point on the east line of said section 35, distant 187.1 foot north of the southeast corner thereof; thence run northwesterly at an angle of 73 degrees 18 minutes with said east section line for 191.26 feet; thence deflect to the left at an angle of 12 degrees 55 minutes 04 seconds for 193.83 feet; thence deflect to the right on a 6 degrees 00 minutes curve (delta angle of 42 degrees 30 minutes) for 361.11 feet; thence run directly perpendicular 50 feet northwesterly to the point of beginning and will be on a line which will run parallel with and distance of 50 feet northwesterly of the following described line; the line parallel 50 feet northwesterly will be the southwesterly line of the described property; thence moving 50 feet southwesterly and perpendicular back to previous described line and in a northwesterly direction continuing 165.72 feet along the curve 6 degrees curve (delta angle 42 degrees 30 minutes); thence on a tangent to said curve for 176.97 feet; thence deflect to left on a 6 degrees 00 minutes curve (delta angle 9 degrees 07 minutes) for 151.94 feet; thence on a tangent to said curve for 107.44 feet; thence on a northwesterly direction at an angle of 90 degrees 00 minutes a distance of 50 feet so as to intersect the southwesterly line of said property; thence northwesterly 400 feet along last described line; this line being the northwesterly side of the described property; thence at a deflection angle to the right 90 degrees and in a southeasterly direction a distance of 600 feet; thence deflect to the right in a southwesterly direction and at an angle of 90 degrees 45.16 feet to the point of beginning, excepting a small triangle cut off the southwest corner described as follows: starting at the southwest corner and run 50 feet northwesterly along the northwesterly line of the property; thence starting again at the southwest corner and run 50 feet southeasterly along the southeasterly line; thence join these two points together forming a triangle at the southwestern corner of the property;
