ORDINANCE NO. 179

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF EAST GRAND FORKS TO INCLUDE CERTAIN UNPLATTED LAND IN THE SE¼ OF THE SW¼ OF SECTION 36, 152-50, NOT EXCEEDING TWO HUNDRED ACRES.

The City Council of the City of East Grand Forks, Minnesota, do ordain:

Section I. A petition has been filed with the City Council of the City of East Grand Forks, Minnesota, by the sole owners of the following described real estate, to have such land included within the City of East Grand Forks, Minnesota:

A tract of land in the Southeast Quarter of the Southwest Quarter (SE ¼-SW¼) of Section Thirtysix (36), Township One Hundred Fifty-two (152) North, Range Fifty (50) West of the Fifth Principal Meridian, which tract is described as follows, to-wit:

Commencing at the Southwest corner of Section 36, Township 152 North, Range 50 West of the 5th Principal Meridian and thence proceeding easterly along the South line of Section 36 for a distance of 2125.15 feet to the true point of beginning; thence deflecting left 90 degrees 14' 10" and proceeding northerly, on a line lying parallel to and 520.00 feet distant westerly from the North-South Quarter Section line of said Section 36, for a distance of 130.00 feet; thence deflecting right 90 degrees 14' 10" and proceeding easterly, on a line lying parallel and 130.00 feet distant northerly from the said South line of Section 36, for a distance of 520.00 feet to an intersection with the said North-South Quarter line in said Section 36; thence deflecting right 89 degrees 45'50" and proceeding southerly, along said North-South Quarter line, for a distance of 130.00 feet to an intersection with the said South line of Section 36; thence deflecting right 90 degrees 14' 10" and proceeding westerly, along said South line of Section 36, for a distance of 520.00 feet to the true point of beginning with said described tract comprised of one and fifty-five-hundredths (1.55) acres lying wholly within the Southeast Quarter of the Southwest Quarter (SE 14-SW 14) of Section Thirty-six (36), Township One Hundred Fifty-two (152) North, Range Fifty (50) West of the Fifth Principal Meridian County of Polk and State of Minnesota.

Section 2. The quantity of land embraced within the foregoing description is 1.55 acres, more or less.

Section 3. The City Council hereby determines (1) that the annexation will be to the best interests of the City of East Grand Forks, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City of East Grand Forks, Minnesota, and is suitably conditioned for municipal government.

Section 4. The corporate limits of the City of East Grand Forks are hereby extended to include the property described in Section 1, and the same is hereby annexed to and

included in the City as effectually as if it had originally been a part thereof

Section 5. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.

Section 6. This Ordinance takes effect upon its passage and publication, and the filing of the certified copies as directed in Section 5.
