ORDINANCE NO. 180

**AN ORDINANCE NO. 180
EXTENDING
THE CORPORATE LIMITS OF
THE CITY OF EAST GRAND
FORKS TO INCLUDE CERTAIN
UNPLATTED LAND IN THE N $\frac{1}{2}$
OF THE S $\frac{1}{2}$ OF THE SW $\frac{1}{4}$ OF
SECTION 36, 152-50, NOT EX-
CEEDING TWO HUNDRED ACRES.**

The City Council of the City of East Grand Forks, Minnesota, do ordain:

Section 1. A petition has been filed with the City Council of the City of East Grand Forks, Minnesota, by the sole owners of the following described real estate, to have such land included within the City of East Grand Forks, Minnesota, to-wit:

A tract of land in the North Half of the South Half of the Southwest Quarter (N $\frac{1}{2}$ -S $\frac{1}{2}$ -SW $\frac{1}{4}$) of Section Thirty-Six (36), Township One Hundred Fifty-two (152) North, Range Fifty (50) West of the Fifth Principal Meridian, which tract is described as follows, to-wit:

Commencing at the Southwest corner of Section 36, Township 152 North, Range 50 West of the 5th Principal Meridian and thence proceeding northerly along the West line of Section 36 for a distance of 850.00 feet; thence deflecting right 90° 11' 15" and proceeding easterly, on a line lying parallel to and 850.00 feet distant northerly from the South line of said Section 36, for a distance of 397.68 feet to the true point of beginning; thence continuing easterly, along said line lying parallel to and 850.00 feet distant northerly from the said South line of Section 36, for a distance of 2246.64 feet more or less to a point of intersection with the Quarter section line running North and South through said Section 36; thence deflecting left 90° 14' 10" and proceeding northerly along the said Quarter Section line for a distance of 474.37 feet to a point of intersection with the Quarter-Quarter Section line running east and west through the Southwest Quarter (SW $\frac{1}{4}$) of Section 36; thence deflecting left 89° 44' 50" and proceeding westerly along the said Quarter-Quarter Section line, for a distance of 2246.18 feet more or less to an intersection with a line lying parallel to and 397.68 feet distant

easterly from the said West line of Section 36; thence deflecting left 90° 12' 15" and proceeding southerly, on a line lying parallel to and 397.68 feet distant easterly from the said West line of Section 36, for a distance of 474.78 feet to the true point of beginning with said described tract comprised of approximately 24.474 acres lying wholly within the North Half of the South Half of the Southwest Quarter (N $\frac{1}{2}$ -S $\frac{1}{2}$ -SW $\frac{1}{4}$) of Section Thirty-Six (36), Township One Hundred Fifty-two (152) North, Range Fifty (50) West of the Fifth Principal Meridian, County of Polk and State of Minnesota.

Section 2. The quantity of land embraced within the foregoing description is 24.474 acres, more or less.

Section 3. The City Council hereby determines (1) that the annexation will be to the best interests of the City of East Grand Forks, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City of East Grand Forks, Minnesota, and is suitably conditioned for municipal government.

Section 4. The corporate limits of the City of East Grand Forks are hereby extended to include the property described in Section 1, and the same is hereby annexed to and included in the City of East Grand Forks as effectually as if it had originally been a part thereof.

Section 5. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.

Section 6. This Ordinance takes effect upon its passage and publication, and the filing of the certified copies as directed in Section 5.


