

ORDINANCE NO. 503

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO AND EXTENDING THE CORPORATE LIMITS OF THE CITY OF FAIRMONT, MINNESOTA

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FAIRMONT, MINNESOTA, AS FOLLOWS:

Section 1. -- That a petition presented to the City Council of the City of Fairmont, Minnesota, requesting that property hereinafter described be annexed to the City of Fairmont has been signed by a majority of the owners of said property; that the said property abuts upon the corporate limits of the City of Fairmont, Minnesota; that it is so conditioned to be property subject to municipal government; that the unplatted part thereof does not exceed two hundred (200) acres in area; that the annexation will be to the best interest of the municipality and the territory effected; that said petition is in accordance with M. S. A. Section 414.03 and is in all things sufficient.

Section 2. -- That a hearing on said petition is required by M. S. A. Section 414.03 has been held pursuant to proper notice thereof, proof of which notice is on file with the City Clerk of the City of Fairmont, Minnesota.

Section 3. -- That the property setforth in said petition is located in the County of Martin, State of Minnesota, and described as follows, to-wit:

Lots One (1) to Seventeen (17), inclusive, of Block One (1),
and Lots One (1) to Eight (8), inclusive, of Block Two (2),
all in Sherbrooke, according to the plat or map thereof on
file and of record in the office of the Register of Deeds in
and for said County and State,
and

The North Half ($N\frac{1}{2}$) of the following described property:
Starting at a point on the East and West Quarter Line of Section
Eighteen (18), Township One Hundred Two (102), Range Thirty (30),
1,180 feet East of Center of said Section as place of beginning,
thence South $61^{\circ} 18'$ East 200 feet, thence West 435.6 feet, thence
North $61^{\circ} 18'$ West 200 feet to the East and West Quarter Line,
thence Easton said Quarter line 435.6 feet to place of beginning,

and that said property be, and the same hereby is, extended to and incorporated within the corporate limits of the City of Fairmont, Minnesota, and is hereby declared to be a part of the City of Fairmont, Minnesota, as effectually as if the same had been originally a part thereof and that the corporate limits be and the same hereby are extended to include said property.
