AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MORTHWOTON TO INCLUDE CERTAIN UNPLATTED LAND.

THE CITY COUNCIL OF THE CITY OF WOPTHINGTON NO URDAIN:

Section 1. A patition has been filed with the City Council of the City of Worthington, Minesota, signed by all of the owners in number, of the following described real estate, to have such land included within the City of Worthington, Minnesotas

That part of the Southeast Quarter (SE) of Section 13, Township 102 North, Range 40 West of the 5th P.M., Nobles County, Minnesota, described as follows: Commencing at a point on the west line of the Southeast Quarter (SE) of Section 13 a distance of 410 feet north of the southwest corner of said section as the place of beginning; thence north on the west line of said quarter section, a distance of 608 feet; thence east and parallel with the south line of said Section 13, a distance of 479.8 feet to the east line of Douglas Avenue, extended, thence south along the east line of Douglas Avenue, extended, a distance of 608 feet; thence west in a direct line to the place of beginning a distance of sproximately 470.5 feet.

Section 2. The quantity of land embraced within the foregoing description, and bounded as described, is six and seven-tenths (6.7) acres.

Section 3. A hearing was duly hold by the City Council of the City of Worthington, Minnesota, on the proposed annexation after publication of the notice of hearing as required by City Charter.

Section it. Scotion 7. This ordinance shall take effect upon its passage and publication and upon filing of the certified copies as directed in Section 6.
