ORDINANCE NO. 40

AN ORDINANCE EXTENDING
THE CORPORATE LIMITS OF
THE VILLAGE OF KILKENNY
TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA

WHEREAS, A certain petition dated October 21st, 1961, requesting the annexation of the territory described below was duly presented to the Council on the 2nd day of November, 1961, which petition was signed and verified by the sole owner of such property; and WHEREAS, the Council has duly considered such petition and all matters therein stated; the Village Council of the Village of Kilkenny, in Le Sueur County, Minnesota do now ordain as follows:

SECTION 1. Declaration. It is nevery deventment that the terri-toy described below abuts upon the Village and is so conditioned as property to be subjected to Village Government. SECTION 2. Territory Annex-ed. The corporate limits of the Village are hereby extended to in-clude the territory described as follows:

Commencing at a point Thirty-two (32) rods North and Fifty-one (51) rods West from the South end of the Center Line between the Southeast Quarter of Section Twenty-Two (22), in Township Number One Hundred Ten (110) North of Range Number Twenty-three (23) West, thence running West One Hundred Seventy-four (174) feet, thence Routh One Hundred Twenty-five (125) feet, thence East One Hundred Seventy-four (174) feet, thence South One Hundred Twenty-five (125) feet to the place of beginning.

SECTION 3. Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance in the office of the Secretary of State and in the office of the County Auditor of Le Sueur County, Minnesota.
