

Ordinance No. 34

An ordinance extending the corporate limits of the Village of Mayer to include certain platted or unplatted land not exceeding 200 acres.

Section 1. A petition has been filed with the governing body of the Village of Mayer, Minnesota by the sole owner or all of the owners in number of the following described real estate to have such land included within the Village of Mayer, Minnesota:

Tract 1. Beginning at a point 703.0 feet South of the Northeast corner of the Southeast Quarter (SE $\frac{1}{4}$) of Section 1, Township 116 North of Range 26 West 99 feet to the actual place of beginning of the land to be described; thence South parallel with the East line of the Southeast Quarter (SE $\frac{1}{4}$) of said Section 1, a distance of 120 feet; thence West 26 feet; thence North parallel with the East line of said Southeast Quarter (SE $\frac{1}{4}$) a distance of 120 feet; thence East a distance of 26 feet to the point of beginning, being a part of Outlot 2 in the Village of Mayer, and a part of said Southeast Quarter (SE $\frac{1}{4}$) of Section 1, Township 116 North of Range 26 West.

Tract 2. Commencing at the Southwest corner of Section 31, Township 117, of Range 25, in the center of the Public Highway; running thence North on West line of said Section, 14.65 rods to a point; thence East at right angles, 14.65 rods to a point; thence due South parallel with West Section line of said Section to the South line of said Section; thence West on said South line of said Section to the place of beginning, excepting therefrom a strip of land 2 rods wide on the West and South sides thereof, for right of way purposes; Said above described piece of land containing one acre of land, exclusive of said right of way, situated in Southwest Quarter of Southwest Quarter (SW $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section 31, Township 117, Range 25.

Section 2. The quantity of land embraced within the foregoing descriptions, and bounded as described, is 1.03 acres, exclusive of land for right of way purposes.

Section 3. The Village Council hereby determines (1) that the annexation will be to the best interests of the Village of Mayer, Minnesota and of the territory affected; (2) that the territory described herein abuts upon the Village and is so conditioned as properly to be subjected to Village government.

Section 4. Therefore, the Village of Mayer, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the Village of Mayer, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the Carver County Auditor and the Secretary of State, and from and after its passage and publication.
