

CONTINUED ON. 504

AN ORGANIC ACT BEING A PETITION TO ADD CERTAIN ADDITIONAL LANDS OF
THE CITY OF FAIRMONT, MINNESOTA.

IS IT GRANTED BY THE CITY COUNCIL OF THE CITY OF FAIRMONT, MINNESOTA, AS FOLLOWS:

Section 1. -- That a petition presented to the City Council of the City of Fairmont, Minnesota, requesting that property heretofore described as annexed to the City of Fairmont has been signed by the owners of said property; that the said property abuts upon the corporate limits of the City of Fairmont, Minnesota; that it is so constituted to be property subject to municipal government; and the unplatted part thereof does not exceed two hundred (200) acres in area; that the annexation will be to the best interest of the municipality and the territory affected; that said petition is in accordance with H.L.A. Section 424.03 and is in all things sufficient.

Section 2. -- That the property aforesaid in said petition is located in the County of Martin, State of Minnesota, and described as follows, to-wit:

A tract of land in lot seven (7), of Block Three (3) of Shore Acres, according to the plan thereof on file and of record, and bounded and described as follows, to-wit:

Beginning at a point on the Eastline of said Block Three (3) 125 foot South of the Northeast corner thereof; thence West 139.5 feet to a point marked by an iron stake on the tangent of a curve; thence Southwesterly 246.3 feet to an iron stake on the arc of said curve of radius 63.94 feet and central angle 13° 3' 20"; thence West 125.05 feet to the said East line of Block Three (3) thence North 246.0 feet to the point of beginning. Area 0.40 acre.

and that said property be, and the same hereby is, annexed to and incorporated within the corporate limits of the City of Fairmont, Minnesota, and is hereby declared to be a part of the City of Fairmont, Minnesota, as effectually as if the same had been originally a part thereof and that the corporate limits be and the same hereby are extended to include said property.
