ORDINANCE NO. 654

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LITTLE FALLS TO INCLUDE CERTAIN PLATTED LAND NOT EXCEEDING 200 ACRES.

The City Council of the City of Little Falls do ordain:

Section 1. The sole purpose in fee of the following described premises situated in the County of Morrison, State of Minnesota, to-wit:

Lots One (1) and Two (2), all in Block One (1) of Broadway Addition to the City of Little Falls.

having duly presented to the City Council a petition in due form to have the above described real estate annexed to and included within the corporate limits of the City of Little Falls.

Section 2. That the quantity of land embraced within the foregoing description, and bounded as described, is 26/100 acres.

Section 3. The City Council hereby determines

- (1) That the annexation will be, to the best interest of the City of Little Falls, Minnesota, and the territory affected;
- (2) That the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City government.

Section 4. That the above described premises do, and the same are hereby annexed to, and included in the City of Little Falls, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall take effect and be in force from and after filing a certified copy thereof with the Minnesota Municipal Commissioner, the County
