

An ordinance concerning certain territory theretofore annexed to the Village of New Richland, Minnesota.

WHEREAS, the owners of tract, parcel and piece of land abutting upon or contiguous to the corporate limits of the Village of New Richland, herein-after described, have petitioned the Council of the Village of New Richland, Minnesota, to have the following described property annexed to the Village of New Richland, to-wit:

All that parcel and tract of land, lying and being in the County of Waseca and State of Minnesota, and described as follows: Commencing at a point on the North-South center line of Section 20, Township 100 North, Range 22 West, 1294 feet South of the center of said Section, thence East 300.5 feet to the point of beginning, said point being on the West line of Lot 3, Block 1, McClain's Second Addition to the Village of New Richland; thence East 66 feet; thence South 194.33 feet thence East 66 feet to a point on the West line of said Block 1 of McClain's addition; thence North along the said West line to the point of beginning, said parcel being a natural extension of Waseca Street as now platted and dedicated.

WHEREAS, The Petitioners are all of the owners of said property and also owners of the property adjacent to said parcel, and whereas the annexation will be to the best interest of the Village of New Richland the territory affected.

NOW THEREFORE, IN IT ORDINANCE BY THE COUNCIL COUNCIL OF THE VILLAGE OF NEW RICHLAND, MINNESOTA, Pursuant to the authority and provisions of Minnesota Statutes Annotated, Section 414.03, subd. 7:

Section 1. That the property hereinbefore described is and the same hereby is annexed to the Village of New Richland, Minnesota.

Section 2. That a duly certified copy of this ordinance shall be filed and recorded in the Office of the Register of Deeds of Waseca County, Minnesota, and in the Office of the County Auditor of Waseca County, Minnesota, and in the Office of the Municipal Commission for the State of Minnesota, State Capitol, St. Paul 1, Minnesota, and in the Office of the Secretary of State for the State of Minnesota, State Capitol, St. Paul 1, Minnesota.

Section 3. This ordinance shall take effect and be in force from and after its publication.
