

ORDINANCE NO. 359

AN ORDINANCE ANNEXING PROPERTY TO THE CITY
OF WHITE BEAR LAKE, MINNESOTA

WHEREAS, the majority of the property owners of the real estate hereinafter described, have petitioned the City Council of the City of White Bear Lake, Minnesota, to have the following described real estate annexed to the City of White Bear Lake, Minnesota; and

WHEREAS, said property does not exceed two hundred (200) acres; and

WHEREAS, on the 11th day of July, 1961, Resolution No. 629 was adopted by the City of White Bear Lake stating the intention of the City to annex the following described real estate and fixing a time and place for hearing; and

WHEREAS, on the 12th day of September, 1961, which was at least ten (10) days after all of the owners and occupants of the land to be annexed were served in the manner provided for the service of a summons in a civil action and a copy of Resolution No. 629 having been published in an official legal newspaper at least ten (10) days before the 12th day of September, 1961, a hearing was duly held by the City Council of the City of White Bear Lake on the proposed annexation; and

WHEREAS, the City Council deems it advisable and in the public interest that said property be so annexed.

NOW, THEREFORE, the City Council of the City of White Bear Lake, Minnesota, does ordain as follows:

Section 1. That the following described real estate situated in Ramsey County, Minnesota:

Subject to Bald Eagle Avenue, the west 333' of the south 366' of the SW 1/4 of Section 11, Township 30, Range 22, according to the plat thereof on file and of record in the office of the Register of Deeds within and for Ramsey County, Minnesota,

be and the same is hereby annexed to the City of White Bear Lake, Minnesota, and the said property is hereby declared to be an addition to said City.

Section 2. Upon the effective date of this Ordinance such property shall become a part of said City as effectively and as if it has been originally a part thereof.

Section 3. This Ordinance shall take effect and be in force from
