## CHAPTER 19.04

## AN ORDINANCE ANNEXING CERTAIN ADJACENT AND ABUTTING REAL ESTATE TO THE VILLAGE OF BUFFALO

That upon the petition of all of the owners of the following described real estate presented to the Village Council at its regular meeting on February 5, 1962, it was determined that it will be to the best interest of the Village of Buffalo and the territory hereinafter described that the said territory be annexed to the Village of Buffalo, the Village Council of Buffalo do ordain:

<u>Section 1.</u> That the following described unplatted real estate, not exceeding 200 acres, and adjacent to and abutting upon the said Village of Buffalo, in the County of Wright and S<sub>t</sub>ate of Minnesota, described as follows, to-wit:

The Northeast Quarter of the Southeast Quarter of Section 31, in Township 120, of Range 25, except the following described parts:

1. A strip of land 1892 feet off the North part thereof which lies East of the center line of the public road crossing said tract;

2. A strip of land 32 rods 10 inches wide on the North part thereof which lies West of the center line of the public road crossing said tract;

3. Beginning 1 rod South and 1 rod WEst of the East Quarter corner of Section 31, in Township 120, of Range 25; thence running West parallel with the quarter section line 509 feet; thence South parallel with the road 173.0 feet to the point of beginning; thence continue South parallel with the road for a distance of 185.0 feet; thence deflect 91° 19' left for a distance of 502.2 feet to a point which is on the highway right of way line; thence deflect 89° 22' left on the highway right of way line for a distance of 185 feet to the point which is on the South line of the present cemetery; thence deflect 90° 38' left along cemetery line for a distance of 500 feet to the point of beginning;

be and the same is hereby annexed to the Village of Buffalo and shall become a part thereof as effectually as if it had been originally a part thereof.

<u>Section 2.</u> That the annexation of the territory described above shall be determined final upon filing of a copy of the ordinance with the Municipal Commission of the State of Minnesota, the Secretary of
