ORDINANCE NO. 147

An Ordinance Annexing Land in Blocks 2 and 3 of Forest Heights Second Addition and in Block 1 of Third Addition to Forest Heights, and in the NW $\frac{1}{4}$  of SW $\frac{1}{4}$  of NE $\frac{1}{4}$  of Section 29, Township 30 North, Range 21 West, to the Village of Mahtomedi, Minnesota.

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI DO ORDAIN  
AS FOLLOWS:

Section 1. That pursuant to that certain petition signed by a majority of the owners of the land hereinafter more particularly described in Washington County, Minnesota, containing less than two hundred acres of platted and unplatted land not included in any other village, city or borough, and adjoining the Village of Mahtomedi, requesting the annexation of said land to said Village, said petition having been duly filed on January 16, 1962, with the Clerk of said Village; and after a public hearing held on said Petition on March 6, 1962, after more than 30 days posted Notice of said hearing at three public places in the area proposed to be annexed and in three public places in said Village of Mahtomedi, and after mailed notice of said hearing to all owners of land in said area proposed to be annexed who had not signed said petition, at their last known addresses according to the records in the office of Treasurer and County Auditor of Washington County, Minnesota, more than 30 days prior to said hearing, and it appearing that such annexation will be to the best interests of the village and of the territory affected, the village boundaries of the Village of Mahtomedi are hereby extended to include the following described land, in Washington County, Minnesota, to-wit:

Commencing at the intersection of the Easterly boundary line of the Village of Mahtomedi and the center line of Wood Street in the plat of Forest Heights Second Addition, thence Easterly along the center line of said Wood Street, to the center line of Fairmount Avenue, also known as Warner Road, thence North along the center line of said Fairmount Avenue to a point which is 411 feet South of

the North line of the Southwest Quarter of the Northeast Quarter (SW 1/4 of NE 1/4) of Section 29, Township 30 North, Range 21 West; thence Easterly on a line parallel with said North section line a distance of 675 feet; thence South on a line parallel to the East line of said Fairmount Avenue, a distance of 264 feet; thence West on a line parallel to said North section line to the Northeast corner of Lot 1 in Block 1 of Forest Heights Third Addition; thence South along the East lines of Lots 1, 2, 3, 4 and 5 in Block 1 of Forest Heights Third Addition to the Southeast corner of Lot 5 in said Block 1; thence West along the South line of said Lot 5 to the East line of said Fairmount Avenue; thence continuing West in a straight line across said Fairmount Avenue to a point on the West line of Fairmount Avenue which is intersected by the center line of that certain East and West, 15-foot lane running along the South lines of Blocks 2 and 3 of Forest Heights Second Addition, thence continuing West along said last mentioned center line to a point which is 7 1/2 feet West of the West line of Lot 7 in Block 3 of Forest Heights Second Addition, and which point is the intersection of said last mentioned center line and the center line of a 15-foot, North and South lane running thru said Block 3 of Forest Heights Second Addition; thence Northerly along said last mentioned center line which line is also an East boundary line of the Village of Mahanomi to the point of beginning on the center line of Wood Street.

and that said territory is hereby made a part of the Village of Mahanomi as effectually as if the same had originally been a part of said village.

Section 2. This Ordinance shall take effect and be in force upon the filing of a certified copy thereof with the County Auditor of Washington County, the Secretary of State of the State of Minnesota and with the State Municipal Commission, and from and after its publication.
