## ORDINANCE NO. 147

An Ordinance Amening Land in Flocks 2 and 3 of Forest Heights Second Addition and in Flock I of Third Addition to Forest Heights, and in the No. of Section 29, Township 30 North, Eurge 21 Feet, to the Village of Maktoraddi, Managota.

AS FOLIOWS:

Section 1. That purcuant to that certain policion algred by a majority of the owners of the land hereinafter more particularly described in Tackington County, Manosota, containing less than two hundred acres of platted and unplatted land not included in any other village, city or borough, and adjoining the Village of Mahtor edi, requesting the ameration of said land to said Village, said petition having been duly filed on January 16, 1962, with the Clerk of said Village; and after a public hearing held on said Petition on March 6, 1962, after more than 30 days posted Notice of said hearing at three public places in the area proposed to be ennered and in three public places in said Village of Mahtomedi, and after mailed notice of sold heaving to all owners of land in said area proposed to be annexed who had not signed said petition, at their last known addresses according to the records in the office of Treasures and County Auditor of Washington County, Minnecota, more than 30 days prior to said hearing, and it appearing that such amenation will be to the best interests of the village and of the territory affected, the village boundaries of the Village of Mahtemedi are hereby extended to include the following described land, in Washington County, Minnesota, to-wit:

Commencing at the intersection of the Easterly boundary line of the Village of Mahtomedi and the center line of Wood Street in the plat of Forest Heights Second Addition, thence Easterly along the center line of said Wood Street, to the center line of Fairmount Avenue, also known as Warner Road, thence North along the center line of said Fairmount Avenue to a point which is 411 feet South of

the North line of the Southwest Cuarter of the Cortheast Quarter (57 of NET) of Section 39. Township 30 Worth. Range 21 Woot: thence Panterly on a line parallel with gald Worth poetion line a distance of 675 foot; thouse South on a line parallel to the East line of oold Fairy ount Avenue, a dictance of 264 feet; thence went on a line posallel to sold North Section line to the Wortheast corner of Lot 1 in Block 1 of Porcet Heighte Third Addition: thence South along the East lines of Lots 1, 2, 3, 4 and 5 in Block I of Forest Meight Third Addition to the Southcaut corner of Lot 5 in said Block I; thence West along the South line of said Lot 5 to the Rast line of said Pairnount Avenue: thence continuing " coterly in a straight line across said Fairmount Avenue to a point on the West line of Fairmount Avenue which is intersected by the center line of that certain East and West, 15-foot lane running along the South lines of Blocks 2 and 3 of Forest Reights Second Addition, thence continuing Vesterly along said last montioned center line to a point which is 73 feet West of the West line of Lot 7 in Block 3 of Forest Heighto Second Addition, and which point is the intersection of said last montioned center line and the center line of a 15-foot, North and South lane running thru said Mock 3 of Forest Heights Second Addition; thence Northerly along cold last mentioned center line which line is also an East boundary line of the Village of Mahtomedi to the point of beginning on the center line of Wood Street.

and that said torritory to hereby made a part of the Village of Mahtomedi ac offectually as of the same had originally been a part of said village.

Section 2. This Ordinance shall take effect and be in force upon the filing of a certified copy thereof with the County Auditor of Washington County, the Secretary of State of the State of Minnesota and with the State Municipal Commission, and from and after its publication.
