**ORDINANCE NO. 182**

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF EAST GRAND FORKS TO INCLUDE CERTAIN UNPLATTED LAND IN THE SE 1/4 OF THE NE 1/4 OF SECTION 35, 152-50, NOT EXCEEDING TWO HUNDRED ACRES.

The City Council of the City of East Grand Forks, Minnesota, do ordain:

Section 1. A petition has been filed with the City Council of the City of East Grand Forks, Minnesota, by the County Board of Polk County, a municipal corporation organized and existing under the Laws of the State of Minnesota, the sole owners of the following described real estate, to have such land included within the City of East Grand Forks, Minnesota, to-wit:

That part of the Southeast Quarter of the Northeast Quarter (SE 1/4 NE 1/4) of Section Thirty-Five (35), Township One Hundred Fifty-two (152) North, Range Fifty (50) West of the Fifth Principal Meridian, described as follows, to-wit:

Beginning at the Southeast corner of the Southeast 1/4 of the Northeast 1/4 of Section 35, Township 152 North, Range 50 West of the Fifth Principal Meridian; thence proceeding westerly, along the East - West Quarter Section line of said Section 35, for a distance of 525.00 feet; thence deflecting right and proceeding northerly, on a line lying parallel to and 525.00 feet distant westerly from the East line of Section 35, for a distance of 40.00 feet to the true point of beginning; thence continuing northerly on said line lying parallel to and 525.00 feet distant westerly from the said East line of Section 35, for a distance of 507.00 feet; thence deflecting left and proceeding westerly, on a line lying parallel to and 547.00 feet distant northerly from the said East-West Quarter Section line of said Section 35, for a distance of 135.00 feet; thence deflecting left and proceeding southerly, on a line lying parallel to and 660.00 feet distant westerly

from the said East line of Section 35, for a distance of 507.00 feet; thence deflecting left and proceeding easterly on a line lying parallel to and 40.00 feet distant northerly from the said East - West Quarter Section line, for a distance of 135.00 feet to the true point of beginning with said described tract comprised of 1.571 acres lying wholly within the Southeast Quarter of the Northeast Quarter (SE 1/4 - NE 1/4) of Section Thirty-Five (35) Township One Hundred Fifty-Two (152) North, Range Fifty (50) West of the Fifth Principal Meridian, County of Polk and State of Minnesota.

Section 2. The quantity of land embraced within the foregoing description is 1.571 acres, more or less.

Section 3. The City Council hereby determines (1) that the annexation will be to the best interests of the City of East Grand Forks, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City of East Grand Forks, Minnesota, is suitably conditioned for municipal government, and is urban in character; (3) that the petitioner is the sole owner of the real estate herein described.

Section 4. The corporate limits of the City of East Grand Forks are hereby extended to include the property described in Section 1, and the same is hereby annexed to and included in the City of East Grand Forks as effectually as if it had originally been a part thereof.

Section 5. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.

Section 6. This Ordinance takes effect upon its passage and publication, and the filing of the certified copies as directed in Section 5.
