ORDINANCE NO. 243

(Independent School District #423)

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF HUTCHINSON TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES.

Section 1. A petition has been filed with the governing body of the City of Hutchinson, Minnesota by the sole owner or all of the owners in number of the following described real estate to have such land included within the City of Hutchinson, Minnesota:

The Northwest Quarter of the Southwest Quarter of Section 1, Township 116 North, Range 30 West, McLeod County, Minnesota.

Section 2. The quantity of land embraced within the foregoing description, and bounded as described, is less than 200 acres.

Section 3. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Hutchinson, Minnesota and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City Government.

Section 4. Therefore, the City of Hutchinson, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the City of Hutchinson, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall take effect and be in force from after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
