AN ORDINANCE PROVIDING FOR  
THE ANNEXATION OF A TRACT OF LAND  
SITUATED IN THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER  
OF SECTION FOUR, T. 115, Range 41 West

The Village of Clarkfield Ordains:

Section 1. That tract of land situated in the southwest quarter of the southeast quarter of Section Four (4), T. 115, R. 41 West, and described as follows:

Starting at the South quarter corner of Section Four (4), Township One Hundred Fifteen (115) North, of Range Forty-one (41) West of the 5th P.M., thence North 1 degree 8 minutes east along the quarter line thirty-three (33) feet to the point of beginning; thence North 1 degree 8 minutes east one hundred forty two (142) feet; thence East one hundred sixty one (161) feet; thence South one hundred forty eight and 5/10th (148.5) feet to the North edge of the State highway; thence North 87 degrees 43 minutes west one hundred sixty three and 8/10ths (163.8) feet to the point of beginning,

is hereby declared to be urban in character and suitable for annexation to the village, and is surrounded by land which is within the municipal limits, and said tract of land is hereby annexed to the Village of Clarkfield.

Section 2. The Clerk is hereby directed to file certified copies of this ordinance with the Municipal Commission, the County Auditor and the Secretary of State.

Section 3. This ordinance shall be effective from and after its passage and publication.
