ORDINANCE NO. 423 (Special)

An Ordinance Extending the Corporate Limits of the City of Willmar to Include Certain Lands not Exceeding Two Hundred Acres in area and Located in Various Parts and Portions of what is now Platted and Known as "Sunnyside Addition" and "Leary's Addition," to-gether with Certain Properties located in the same General Area owned by Harry L. Erickson, which are not platted, except that the same shall hereafter

be known as the "Harry L. Erickson Addition to the City of Willmar" for general descriptive purposes. BE IT ORDAINED BY THE CITY OF WILLMAR AS FOLLOWS:

SECTION 1.

Petitions have been filed with the governing body of the City of Willmar, Minnesota, by the sole owner or owners of the following described real estate, to have such land included within the City of Willmar, Minnesota, as follows:

within the City of Willmar, Minnesota, as follows: 1. (That area encompassed within what is known as "Sunnyside Addition"). Lots Five and Six (5 and 6) in Block One (1); the South Sixty Five and one tenth (S 65.1) feet of the East Two Hundred One (E 201) feet of Lot Seven-teen (17), and the East Two Hundred (E 200) feet (less the South Sixty (60) feet thereof) of Lot Eighteen (18), all in Sunnyside Addition to the City of Willmar and in a sub-division of part of the North Half of the Northeast Quarter (N¹/₂ of NE¹/₄) of Section Twenty Two (22), Township One Hundred Nineteen (119), Range Thirty Five (35), Kandiyohi County, Minnesota, according to the recorded plat thereof. 2. (That area encompassed within what is known as

2. (That area encompassed within what is known as "Leary's Addition"). Lot One (1) in Block One (1); and the North Half of Lot Ten (N½ of Lot 10) all in Leary's Addition to the City of Willmar, Kandiyohi County, Minnesota, according to the recorded plat thereof.

3. (That area encompassed within what shall be known as the "Harry L. Erickson Addition to the City of Willmar" for descriptive purposes only). The West Half of the South-east Quarter of the Northeast Quarter (W½ of SE¼ of NE¼) except Minnesota State Trunk Highway right-of-way, Kandiyohi County, Minnesota, according to the recorded plat thereof.

SECTION 2.

The quantity of land embraced within the foregoing description, and all of them, and bounded as described is approximately Ninteen and seventy five hundredths (19.75) acres.

SECTION 3.

The City Council hereby makes the following determina-

tion, to-wit: 1. That the annexation will be to the best interest of the City of Willmar, Minnesota, and of the territory affected. 2. That the territory described herein abuts upon the City and is so conditioned as properly to be subject to City Government.

SECTION 4.

Wherefore, the City of Willmar, Minnesota, a Municipal Corporation of said State of Minnesota, hereby ordains and declares that the property hereinbefore described be, and the same is hereby annexed to, and included in the City of Willmar, Minnesota, as effectually as if it had originally been a part hereof.

SECTION 5.

This Ordinance shall be final and shall take effect and be in full force from and after filing a certified copy hereof with the Minnesota Municipal Commission, the County Audi-tor of the Kandiyohi County, Minnesota, and the Secretary of State of the State of Minnesota, and from and after its passage and publication.


