IN RE: PARTITION OF THE PROPERTY OF THE VILLAGE OF
CROOK AND THE CITY OF WAYZATA PUR THE AMALGAMATION
INTEREST AND ATTACHMENT OF CERTAIN PROPERTY
ACQUISITION THEREIN MADE LATE 1900, CHAPTER 666,
SECTION 6, SUBDIVISION 2 AS HEREBY.

A. A. D. C. S.

The Village of Crook has, by resolution of the Village
Council at a meeting held on April 9, 1902, partitioned for
the detachment of certain property herein after described,
and the City of Wayzata has, at a meeting of the City Coun-
cil held on April 11, 1902, partitioned to annex the same
property, pursuant to Law 1900, Chapter 666, Section 6,
Subdivision 2 as aforesaid.

The territory involved consists of:

"That part of Section 3 1/4 of Township 1/4 East of the
Fifth Principal Meridian, described as follows:
Commencing at Southeast corner of said Section 35;
thence Northwesterly along South 14th of said Section
a distance of 545.2 feet to Northwest corner 14th of
Section 35 thence Northwesterly of way thence Northwesterly
along said right of way 14th a distance of 650.0
feet to 4th intersection with West 14th of said
Section 35 1/4 of Section 3 1/4 of Section 35; thence
Northwesterly along said West 14th of said Section 35
1/4 of Section 3 1/4 a distance of 80.7 feet; thence
Northerly parallel with and distant 305.0 feet there-
from as right angle from South 14th of said Section 35
a distance of 1011.09 feet to Northwest corner 14th
of Section 35 thence No. 10, or new line cut and numbered
thence Northwesterly along said Southeasternly 14th
of highway a distance of 392.7 feet to its intersection
with New line of said Section 35; thence South-
erly a distance of 142.0 feet to point of beginning."

All of the requirements of the statute having been met,

IT IS ORDERED: That the above described real property be,
and hereby is, detached from the Village of Crook and annexed
to the City of Wayzata, the same as if it had originally been #15802
a part thereof.
