

ORDINANCE NO. 2

An ordinance detaching Real Estate  
and territory from the Village of  
Greenwald, Stearns County, Minnesota.  
\*\*\*\*\*

That whereas at an election duly called and held in  
the said Village of Greenwald on the 14th day of March, 1916, for the  
purpose of voting upon the proposition as to whether the Real  
Estate and territory hereinafter described should be detached from  
the Village of Greenwald, aforesaid, a majority of the ballots cast  
at said election were cast in favor of detaching said real estate and  
territory from said village.

Now, therefore,

The Village Council of the Village of Greenwald in  
the County of Stearns, State of Minnesota, do ordain as follows:

Section 1. That the following described real estate  
and territory which heretofore formed a part of the village of  
Greenwald be and the same is hereby detached from and taken out of  
the said municipal corporation, viz: said Village of Greenwald, to-  
wit:

The SW $\frac{1}{4}$  of the NE $\frac{1}{4}$  less that part of same lying north-  
erly and westerly of the Spring Hill road and less the northerly 200  
feet of that part of said SW $\frac{1}{4}$  of NE $\frac{1}{4}$  east of said road and less the  
Right of Way of the "S00" railway across the same, containing 26.56  
acres, in section 28.

That part of the SW $\frac{1}{4}$  of the NE $\frac{1}{4}$  lying north-westerly of  
the Spring Hill road and the northerly 200 feet of that part of said  
SW $\frac{1}{4}$  of NE $\frac{1}{4}$  lying east of said road containing 11.30 acres, section 28.

The NE $\frac{1}{4}$  of the NW $\frac{1}{4}$  and the E $\frac{1}{2}$  of NW $\frac{1}{4}$  of the NW $\frac{1}{4}$  contain-  
ing 60 acres, in section 28.

W $\frac{1}{2}$  of the NW $\frac{1}{4}$  of the NW $\frac{1}{4}$  containing 20 acres, section 28.

The SW $\frac{1}{4}$  of the SE $\frac{1}{4}$  of the NW $\frac{1}{4}$  less Right of Way, also  
the E 1 rod of the SE $\frac{1}{4}$  of SW $\frac{1}{4}$  of the NW $\frac{1}{4}$  containing 9.75 acres,  
section 28.

The NW $\frac{1}{4}$  of the SE $\frac{1}{4}$  of NW $\frac{1}{4}$ , the N $\frac{1}{2}$  of SW $\frac{1}{4}$  of NW $\frac{1}{4}$  and the  
SW $\frac{1}{4}$  of the SW $\frac{1}{4}$  of the NW $\frac{1}{4}$  and the SE $\frac{1}{4}$  of the SW $\frac{1}{4}$  of the NW $\frac{1}{4}$  less the  
East 1 rod in all containing 49.75 acres, section 28.

The  $N\frac{1}{2}$  of the  $SW\frac{1}{4}$  less the "Soo" Right of Way and that part of the  $SE\frac{1}{4}$  of the  $NW\frac{1}{4}$  described as follows:-Beginning at the center of section 28, thence north 304 feet to the center of the Spring Hill road; thence south-west along the center of said road to the East and West quarter section line; thence east to the place of beginning containing all 75.36 acres, section 28.

That part of the  $E\frac{1}{2}$  of the  $SE\frac{1}{4}$  of the  $NW\frac{1}{4}$  of section 28, lying west of the Spring Hill road less right of way of "Soo" railway, said tract containing 17.71 acres, section 28.

The  $S\frac{1}{2}$  of  $SW\frac{1}{4}$  and the  $SW\frac{1}{4}$  of the  $SE\frac{1}{4}$  section 28 containing 120 acres.

The  $W\frac{1}{2}$  of the  $SE\frac{1}{4}$  of the  $NE\frac{1}{4}$  and the  $S$  23.10 acres of the  $SW\frac{1}{4}$  of the  $NE\frac{1}{4}$  of section 29, containing 43.10 acres,

The North 16.90 acres of the  $SW\frac{1}{4}$  of the  $NE\frac{1}{4}$  section 29, containing 16.90 acres.

The  $E\frac{1}{2}$  of the  $SE\frac{1}{4}$  of the  $NE\frac{1}{4}$  of section 29, containing 20 acres.

The  $S\frac{1}{2}$  of the  $NW\frac{1}{4}$  of section 29, containing 80 acres.

The  $S\frac{1}{2}$  of the  $NE\frac{1}{4}$  of section 30, containing 80 acres.

The  $SW\frac{1}{4}$  of the  $SE\frac{1}{4}$  and the  $SE\frac{1}{4}$  of the  $SE\frac{1}{4}$  of section 30, containing 80 acres.

The  $NE\frac{1}{4}$  of the  $NE\frac{1}{4}$  of section 31 less the "Soo" Right of Way containing 36.72 acres.

The  $NW\frac{1}{4}$  of the  $NE\frac{1}{4}$  of section 31 less right of way containing 39.63 acres.

The  $S\frac{1}{2}$  of the  $SW\frac{1}{4}$  of section 32, containing 80 acres.

The  $NE\frac{1}{4}$  of the  $SE\frac{1}{4}$ , the  $S\frac{1}{2}$  of the  $SE\frac{1}{4}$ , the  $NW\frac{1}{4}$  of the  $SE\frac{1}{4}$  all in section 32, containing 160 acres.

N  $17\frac{1}{2}$  acres of the  $NW\frac{1}{4}$  of the  $NE\frac{1}{4}$  of section 33, containing  $17\frac{1}{2}$  acres.

The South 23.50 acres of the  $NW\frac{1}{4}$  of the  $NE\frac{1}{4}$  of section 33, containing 23.50 acres.

The  $SW\frac{1}{4}$  of the  $NE\frac{1}{4}$  of section 33, containing 40 acres.

The  $W\frac{1}{2}$  of the  $NW\frac{1}{4}$ , section 33, less that part south of the county road.

All of the  $SW\frac{1}{4}$  of the  $NW\frac{1}{4}$  section 33, south of the county road and containing 8 acres.

The  $SW\frac{1}{4}$  of section 33, containing 160 acres.

The  $E\frac{1}{2}$  of the  $NW\frac{1}{4}$  section 33, containing 80 acres.

The  $E\frac{1}{2}$  of the  $NE\frac{1}{4}$  section 33 containing 10 acres.

Section 2. This ordinance shall take effect and be in force from and after its publication.

Passed and enacted by majority of votes of all the members of the Village Council of the said Village of Greenwood, this 20th day of March, 1916.
