

ORDINANCE NO. 113

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE VILLAGE OF OLIVIA.

The Council of the Village of Olivia do ordain as follows:

Section 1 - The following described township roads abutting upon the incorporated Village of Olivia are hereby annexed to such village and shall become a part of such village as effectually as if they had originally been a part thereof:

All that portion of the township road and adjacent right-of-way lying between Sections 11 and 12 of Troy Township and lying south of the southerly right-of-way line of Chicago, Milwaukee, St. Paul and Pacific Railroad Company, and all that portion of the township road and adjacent right-of-way lying between Sections 12 and 13 of Troy Township lying east of the section corner where Sections 11, 12, 13 and 14 of Troy Township join; and all of which roadways and rights-of-way have in the past been operated and maintained by the Town of Troy.

Section 2 - This ordinance shall be in full force and effect from and after the date of its publication.

RESOLUTION

At a duly called and held special meeting of the Village Council of the Village of Olivia, Kenville County, Minnesota, the matter of the annexation of land to the Village of Olivia came up for discussion. The three supervisors of the Town Board of the Town of Troy, Gene Dillen, Wesley Kusko and Wallace Penko were present. From the information available to the Council and upon the oral petition of the Troy Town Board members present, it appears that the real estate hereinafter described is properly conditioned so as to be subjected to and benefited by municipal government and that the annexation as proposed will be to the best interests of the Village of Olivia and the Town of Troy.

After discussion of said matter, M. S. Nelson proposed the following resolution and moved its adoption, to-wit:

WHEREAS, the said lands are properly conditioned for administration by municipal government and it will be to the best interests of the Village of Olivia and the Town of Troy that said lands be annexed to the corporate Village of Olivia, and

WHEREAS, said lands are described as follows:

All that portion of the township road and adjacent right-of-way lying between Sections 11 and 12 of Troy Township and lying south of the southerly right-of-way line of the Chicago, Milwaukee, St. Paul and Pacific Railroad Company, and all that portion of the Township Road and adjacent right-of-way lying between Sections 12 and 13 of Troy Township lying east of the section corner where Sections 11, 12, 13 and 14 of Troy Township join; and all of which roadways and rights-of-way have in the past been operated and maintained by the Town of Troy.

NOW, THEREFORE, BE IT RESOLVED by the Village Council of the Village of Olivia, that the lands hereinabove described be and the same are hereby annexed to the corporate limits of the Village of Olivia, Minnesota.

Mayer H. W. Dickinson seconded the motion for the adoption of such resolution and upon submission thereof, said resolution was unanimously adopted.
