AN ORDINANCE PROVIDING FOR ANNEXATION OF TERRITORY TO THE VILLAGE OF SPRING VALLEY, MINNESOTA

THE VILLAGE COUNCIL OF THE VILLAGE OF SPRING VALLEY, MINNESOTA DO ORDAIN AS FOLLOWS:

A petition having been filed in accordance with the provisions of the Laws of Minnesota 1959, Chapter 686, Section 3, Subdivision 2, as amended, it is hereby determined that the annexation of the following described property located in the County of Fillmore, State of Minnesota, to-wit:

Commencing at the Southwest corner of the Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$ NE $\frac{1}{4}$) of Section Twenty-eight (28), Township One Hundred Three (103), Range Thirteen (13), thence East Three Hundred Thirty (330) feet for a point of beginning, thence East One Hundred Sixty-five (165) feet, thence South Six Hundred Sixty (660) feet, thence West One Hundred sixty-five (165) feet, thence North Six Hundred Sixty (660) feet to place of beginning.
