

ORDINANCE NO. 78

AN ORDINANCE PROVIDING FOR ANNEXATION OF TERRITORY TO THE VILLAGE OF
SPRING VALLEY, MINNESOTA

THE VILLAGE COUNCIL OF THE VILLAGE OF SPRING VALLEY, MINNESOTA, DO ORDAIN
AS FOLLOWS:

A petition having been filed in accordance with the provisions
of the Laws of the State of Minnesota 1959, Chapter 686, Section 3,
Subdivision 2, as amended, it is hereby determined that the annexation of the
following described property located in the County of Fillmore, State of
Minnesota, to-wit:

Commencing at a point Three Hundred Twenty and 5/10 (320.5)
foot West of the center of Section Twenty-eight (28), Town-
ship One Hundred Three (103) North Range Thirteen (13) West
thence North Nine Hundred Ninety-Nine and 8/10 (999.8) feet,
thence North Thirty-Three Degrees Twenty-Five Minutes (33°25')
West Three Hundred Fifty-Six (356) feet, thence North Fifty-
Seven Degrees Thirty-Five Minutes (57°35') East One Hundred




