

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF HAMBURG TO INCLUDE CERTAIN UNPLANNED LAND NOT EXCEEDING 200 ACRES.

Section 1. A petition has been filed with the governing body of the Village of Hamburg, Minnesota by the sole owner, viz: Harold Bohman, of the following described real estate situate in Carver County, Minnesota, to have such land included within the Village of Hamburg, Minnesota, to-wit: All that part of the following described tract lying outside of the Village limits of Hamburg, Minnesota:

Commencing at the South Quarter corner of Section 28 Township 115 North Range 26 West; thence West on the South line of said Section 28, assumed to bear 90° West of true North, for 875.82 feet; thence North 61°47' West for 271.87 feet to the point of beginning, of this description; thence North 61°37'10" West for 80.00 feet; thence North 55°40'40" West for 80.00 feet; thence North 51°03'10" West for 134.00 feet; thence North 60°12'34" West for 201.35 feet to the East right of way line of the Northwestern Railroad; thence North 55°35'10" East along said right of way line for 196.7 feet; thence South 54°24'30" East for 50.00 feet; thence North 55°25'10" East for 50.00 feet; thence North 54°34'50" West for 50.00 feet; thence North 55°12'15" East for 20.20 feet; thence South 55°12'40" East for 104.25 feet; thence North 55°10'55" East for 100.00 feet; thence South 55°14'15" East for 176.00 feet; thence South 52°19'55" East for 100.00 feet; thence South 53°05'50" East for 100.00 feet; thence South 54°45'20" East for 100.00 feet; thence South 71°04'30" East for 100.00 feet; thence South 55°15'05" West for 200.00 feet; thence North 51°03'25" West for 141.00 feet; thence South 27°49'25" West 152.20 feet to the point of beginning.

Section 2. The quantity of land embraced within the foregoing description and bounded as described is approximately 6 acres, more or less.

Section 3. The Village Council hereby determines (1) that the Amendment will be to the best interest of the Village of Hamburg, Minnesota and of the territory affected. (2) that the territory described herein abuts upon the Village and is so conditioned as property to be subjected to Village Government.

Section 4. Therefore the Village of Hamburg, Minnesota hereby ordains and declares that the property heretofore described be and the same is hereby annexed to and included in the Village of Hamburg, Minnesota as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall take effect and be in force from and after filing a certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
