

AN ORDINANCE EXPLAINING THE CORPORATE LIMITS
OF THE VILLAGE OF HANFORD TO INCLUDE CERTAIN
UNPAVED LAND NOT EXCEEDING 200 ACRES.

Section 1. - A petition has been filed with the governing body of the Village of Hanford, Minnesota by the sole owner, viz: Arnold Panning, of the following described real estate situated in Carver County, Minnesota, to have such land included within the Village of Hanford, Minnesota, to wit: All that part of the following described tract lying outside of the Village limits of Hanford, Minnesota:

Commencing at the South Quarter corner of Section 28
Running 115 North Range 25 West; thence West on the
South Line of said Section 28, assued to bear 99°
West of true North, for 875.00 feet; thence North 61°07' West for
271.67 feet to the point of beginning; thence
North 61°07' West for 80.00 feet; thence North 55°04'00" West for
60.00 feet; thence North 55°04'00" West for 134.00 feet; thence North
55°12'00" West for 271.35 feet to the East right of the line of the
Minneapolis Railroad; thence North 35°08'10" East along said right of
way line for 106.7 feet; thence South 54°21'30" East for 80.00 feet;
thence North 35°08'10" East for 98.00 feet; thence North 54°21'30" East
for 80.00 feet; thence North 35°10'15" East for 80.00 feet; thence
South 54°04'00" East for 100.00 feet; thence North 35°10'55" East for
100.00 feet; thence South 54°04'15" East for 876.00 feet; thence South
54°10'00" East for 100.00 feet; thence South 54°08'15" East for 100.00
feet; thence South 54°08'20" East for 100.00 feet; thence South 71°00'00"
for 100.00 feet; thence South 35°08'05" West for 80.00 feet;
thence North 35°08'05" West for 134.00 feet; thence South 47°04'25"
West for 80.00 feet to the point of beginning.

Section 2. - The quantity of land proposed within the foregoing
description and bounded as described is approximately
6 acres, more or less.

Section 3. - The Village Council hereby determines (1) that the
incorporation shall be to the best interest of the Village
of Hanford, Minnesota and of the territory adjacent. (2) that the
corporation shall herein suffice upon the Village and is so constituted
as properly to be subjected to Village Government.

Section 4. - Incorporate the Village of Hanford, Minnesota hereby
extending and enlarging the property boundaries
described by and the same so hereby created or and extended as
in the Village of Hanford, Minnesota as effectually as if it had
originally been a part thereof.

Section 5. - This ordinance shall be final and shall take effect and
be in force from and after filing a certified copy
thereof with the Minnesota Municipal Commission, the County Auditor
and the Secretary of State, all three and after its passage and
publication.
