AN ORDINANCE ALTIEVING PROPERTY TO THE VILLAGE OF PRIOR LAUE, LYMNESOTA

Starting at a point on the South line of Government Lot 2 of Section 2, Tounchip 114, Range 22, 300 feet West of the Southeast corner of said Government Lot 2, thence North and parallel to the East line of said Government Lot 2, 391.5 feet to the point of beginning, thence East 150 feet, thence North 290.5 feet, to the South line of Pleasant Avenue, thence West 150 feet, thence South 290.5 foot,

SECTION 1.

which lies outside the corporate limits of the Village of Frior Lake, Minnesota, be and the same is hereby annexed to the Village of Frior Lake, Minnesota, and said property is hereby declared to be an addition to said Village.

Upon the execution date of this Ordinance, such property shall become a part of said Village as effectively as if it had been originally a part thereof.
