ORDINANCE NO. 179

AN ORDINANCE RELATING TO THE ANNEXATION OF CENTAIN PROPERTY TO THE CITY OF ALEXANDRIA, MINNESOTA, DECLARING THE WARDS TO WHICH IT SHALL BE ATTACHED, AND EXTENDING THE CORPORATE LIMITS TO ENCOMPASS SAID LAND.

WHEREAS A. P. Hustad has filed with the City Council a petition indicating that he is the solo owner of the hereinafter described property lying and being in the County of Douglas and State of Minnesota; that said land abuts upon the corporate limits of the City of Alexandria; and is unplatted; and does not exceed 200 acres in area; and is not a homestead, and

WHEREAS the governing body of the City of Alexandra has examined said perition, determined the facts therein stated to be true, that said property is so conditioned as properly to be subjected to municipal government, and that the annexation of said property would be for the best interests of the municipality, and of the territory affected and to be annexed,

NOW THEREFORE, the City Council of the City of Alexandria does ordain:

SECTION I. That it is for the best interests of the municipality of the City of Alexandria and of the territory hereinafter described, that said territory be annexed to and be made a part of the municipality of the City of Alexandria,

SECTION II. That the following described land, to wit: That part of the Northeast Quarter of the Northwest Quarter of the Northwest Quarter of Section 30. Township 128, Range 37, described as follows: Beginning at a point 576 feet west of the southeast corner of said northeast quarter of the Northwest Quarter, thence west along the forty line 284 feet; thence north 98.8 feet to the southeasterly right of way limits of T.H. No. 29; thence in a northeasterly direction for twenty two and five tenths (22.5) feet along the said southeasterly right of way limits; thence east 267.7 feet; thence south 115 feet to the point of beginning, said tract containing 0.747 acres more or less; AND That part of the northeast quarter of the Northwest Quarter of Section 30, Township 128, Range 37, described as follows: Beginning at a point 860 feet west along the forty line 440 feet north of the Southeast Corner of said Northeast Quarter of the Northwest Quarter; thence east and parallel to the forty line for a distance of 131 feet to the northwesterly right of way limits of the T.H. No. 29, thence in a southwesterly direction along said right of way for a distance of 184 feet; thence north 130.5 feet to the point of beginning, said tract containing 0.2 acres more or less

is hereby annexed to and made a part of the municipality of the City of Alexandria, and the corporate limits of the City of Alexandria, Minnesota, shall be and hereby are extended to include and encompass the land and territory above described.

SECTION III. All of said land and territory described by limits, description and boundaries in Section II above, and hereby annexed to and made a part of the City of Alexandria, Minnesota, shall be and does hereby become a part of
