## ORDINANCE NO. 180

AN ORDINANCE RELATING TO THE ANNEXATION OF CERTAIN PROPERTY TO THE CITY OF ALEXANDRIA, MINNESOTA, DECLARING THE WARDS TO WHICH IT SHALL BE ATTACHED, AND EXTENDING THE COMPORATE LIMITS TO ENCOMPASS SAID LAND.

WHEREAS, Walter Roth has filed with the City Council a petition indicating that he is the sole owner of the hereinefter described property lying and being in the County of Douglas and State of Minnesota; that said land abuts upon the corporate limits of the City of Alexandria; is unplatted, and does not exceed 200 acres in area; and is not a homestead, and

WHEREAS the governing body of the City of Alexandria has examined said petition, determined the facts therein stated to be true, that said property is so conditioned as properly to be subjected to municipal government, and that the annexation of said property would be for the best interests of the municipality, and of the territory affected and to be annexed.

NOW THEREFORE, the City Council of the City of Alexandria does ordain:

SECTION I. That it is for the best interests of the municipality of the City of Alexandria and of the territory hereinafter described, that said territory be annexed to and be made a part of the municipality of the City of Alexandria.

SECTION II. That the following described land, to wit: That part of the Northwest Quarter of Section 30, Township 128, Range 37, described as follows: Beginning at a point 99.2 feet east of the one quarter corner between sections 19 and 30, Township 128, Range 37, thence in a southwesterly direction bearing South 12° 30' West for a distance of 153,3 feet, thence in a southwesterly direction bearing South 1 15' 30" West for a distance of 586.3 feet, to the point of beginning, thence from the point of beginning east 349 feet, thence south 426 feet, thence west 349 feet more or less to the easterly limits of public highway, thence north along the east border of said highway a distance of 426 feet more or less to the point of beginning, containing in all 3.4 acres more or less,

is hereby annexed to and made a part of the municipality of the City of Alexandria, and the corporate limits of the City of Alexandria, Minnesota, shall be and heraby are extended to include and encompass the land and territory above described.

SECTION III. All of said land and territory described by limits, description and boundaries in Section II above, and hereby annexed to and made a part of the City of Alexandria. Minnesota, shall be and does hereby become a part of the fourth ward of the City of Alexandria.

SECTION IV. This ordinance shall take effect from and after its passage and publication in accordance with the laws of the State of Minnesota, the Charter of the City of Alexandria, and upon the filing of this ordinance
