ORDINANCE
State of Minnesota, County of Otter
Tail ss. Village of Dent.
ORDINANCE NO. 25
Ordinance to extend boundary to
Village of Dent.
That the following described prop-
erty abutting and adjoining the
Village of Dent, to-wit:
"A" Joan Darco and Daniel Darco,
Jr., her husband.
A tract of land containing 1 1/2 acres
described as follows:
Starting at a point that is sixteen
(16) rods north of the Southeast cor-
ner of the Southeast Quarter of
Northeast Quarter (SE 1/4 of NE 1/4),
Section Thirty-three (33), Township One
Hundred Thirty-six (136), Range
Forty (40), thence twenty (20) rods
west, thence twelve (12) rods north,
thence twenty (20) rods east, thence
twelve (12) rods south along public
road to the place of beginning.
"B" Wilbert A. Rinas and Willma
A. Rinas, his wife.
North eight (8) rods of south six-
teen (16) rods of east twenty (20)
rods of Southeast Quarter of North-
east Quarter (SE 1/4 of NE 1/4), Sec-
tion Thirty-three (33), Township One
hundred Thirty-six (136), Range
Forty (40).
"C" Eugene J. Stoll and Marian F.
Stoll, his wife.
Southeast Quarter of Northeast
Quarter (SE 1/4 of NE 1/4), except tract
and Lot One (1), except 2.90 acres,
Section Thirty-three (33), Township
One hundred Thirty-six (136), Range
Forty (40), and which said lands are
unplatted and does not exceed 200
acres, be and the same is hereby
made part of the Village of Dent,
Otter Tail County, Minnesota, and in-
cluded within said Village and the
boundary within said village, and
hereby extended to include the same
and the whole thereof.
That this ordinance is passed pur-
suant to a petition of a majority of
the owners of the land of the above
described premises, filed with the
Village Council on the 5th day of
April, 1962.
Praying that the said land might
be annexed to said Village.
This ordinance is to take effect
upon its passage and publication.
