AN ORDINANCE DECLARING CERTAIN
LAND TO BE ANNEXED TO THE CITY
OF NORTH MANKATO, MINNESOTA

THE COMMON COUNCIL OF THE CITY OF NORTH MANKATO, MINNESOTA, DO
ORDAIN AS FOLLOWS:

SECTION 1. All that tract or parcel of land lying adjacent to
the City of North Mankato and being all in the County of Nicollet, and
described as follows:

That certain tract or parcel of land lying within the Northwest Quarter (NW $\frac{1}{4}$)
of the Southwest Quarter (SW $\frac{1}{4}$) of Section Number Eleven (11), in Township
Number One Hundred and Eight (108) North of Range Number Twenty-seven (27)
West circumscribed as follows, to-wit:
Commencing at a point 71.6 feet East and 370 feet south of the Northwest
Corner of the Southwest Quarter (SW $\frac{1}{4}$) of the said Section Number Eleven (11),
Township Number One Hundred Eight (108) North of Range Twenty-seven (27)
West, thence running due East a distance of Three Hundred (300) feet, thence
due South One Hundred Nineteen and five-tenths (119.5) feet; thence South
61 degrees 41 minutes West Two Hundred Seven and three-tenths (207.3) feet,
to the right of way line of U.S. Trunk Highway No. 14, thence North 28 degrees
16 minutes west along the said right of way line of said U.S. Trunk Highway
Two Hundred Forty-seven and four-tenths (247.4) feet to the place of beginning.

is hereby deemed to be suitably conditioned for municipal
government and is hereby annexed and hereby declared to be a part of the
City of North Mankato, County of Nicollet, State of Minnesota, and to be
included in the corporate limits thereof.

SECTION 2. This ordinance shall take effect from and after
its passage and publication.
