IN THE MATTER OF THE PETITION FOR DETACHMENT OF
REAL ESTATE FROM THE VILLAGE OF NOIRE GROVE,
MINNESOTA UNDER LAWS 1959, CHAPTER 606, SECTION
6, SUBDIVISIONS 1 AND 3.

O R D E R

The Village of Noire Grove has, by resolution at a regular meeting of the Village Council held April 6, 1962, petitioned for the detachment of certain property adjacent to the municipal boundary, unplatted, and occupied and used exclusively for agricultural purposes, hereinafter described, from the Village of Noire Grove, Minnesota. An identical petition has also been received from all of the owners of the property affected.

The territory involved consists of:

"The East Quarter of the Southeast Quarter (E $\frac{1}{4}$ of SE $\frac{1}{4}$), of Section Seven (7), Township One Hundred Twenty-five (125), Range Thirty-three (33). (40 acres).

The East Half of the Northeast Quarter of the Northeast Quarter (E $\frac{1}{2}$ of NE $\frac{1}{4}$), of Section Eighteen (18), Township One Hundred Twenty-five (125), Range Thirty-three (33). (20 acres).

The East Half of the Southeast Quarter of the Northeast Quarter (E $\frac{1}{2}$ of SE $\frac{1}{4}$ of NE $\frac{1}{4}$), of Section Eighteen (18), Township One Hundred Twenty-five (125), Range Thirty-three (33). (20 acres).

The West Quarter of the Southwest Quarter of the Northwest Quarter (W $\frac{1}{4}$ of SW $\frac{1}{4}$ of NW $\frac{1}{4}$), of Section Seventeen (17), Township One Hundred Twenty-five (125), Range Thirty-three (33). (10 acres)."


The property is unplatted and is used and occupied exclusively for agricultural purposes. This detachment would not unreasonably affect the symmetry of the municipality.


