Extracts from By-Laws of the General Insurance Company of America, adopted February 28, 1923, and amended April 27, 1950, by the Stockholders:

"Article V, Section 3.--POWERS AND DUTIES OF PRESIDENT:....He shall also have power and authority to designate individuals under appropriate
titles who shall be authorized to execute on behalf of the Company fidelity and surety bonds and other documents of similar character issued by the
Company in the course of its business and who may also have authority to attach the official seal of the Company to such fidelity and surety bonds
and documents of like character issued by the Company in the course of its business."

"Article V, Section 4.--POWERS AND DUTIES OF VICE-PRESIDENT:....In the absence of the President, the Vice-President, or if more than one
Vice-President, the Vice-Presidents in the order of their election shall perform the duties of the President, subject to the direction of the Board of
Directors. He shall also have power and authority to designate individuals under appropriate titles who shall be authorized to execute on behalf of
the Company fidelity and surety bonds and other documents of a similar character issued by the Company in the course of its business and who may
also have authority to attach the official seal of the Company to such fidelity and surety bonds and documents of like character issued by the Com-
pany in the course of its business."

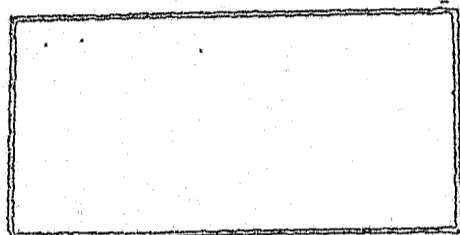
